## **TERMS AND CONDITIONS**

1. The period of contract is for **TWO YEARS**.
2. Our requirement of luxury cars/vans is sporadic. **(Need based—not regular)**.
3. The contractors may quote the rates for any type of luxury cars which can be able to supply.
4. Luxury cars and passenger vans contract mostly differ from our regular non AC taxi contract by the way of last minute and late hour requirements/cancellation, the Travel operators/Contractors from outside Trichy may find it difficult to cope up with our last minute requirements/Cancellation and hence **LUXURY TAXI OPERATORS should have office at Trichy before award of work.**
5. Contract will be finalized on a L1 basis on single vendor for each type of vehicle. If L1 is not able to meet the indicated max qty indicated L1 rate will be counter offered (L2, L3 and so on has to match their item wise price to that of L1) to L2, L3 and so on for the balance qty. The L1 bidder will be given due percentage of work
6. The drivers should be paid as per the Government minimum wage Act **an additional payment as per circular ref. BHE/HR/W/MW/dt.16.08.2011 is to be paid to the contract workmen as below, over and above the Minimum Wages prescribed by the Government of Tamilnadu:**  
  
**Skilled - Rs.2500/-**  
**A minimum Bonus @ 8.33 % to Driver to be paid.**
7. **All The drivers should have coverage under PF/ESI/CONTRACT LABOUR REGULATIONS ACT. The travels should have separate registration in their own name and all their drivers should be covered.**
8. Taxi operator should have local office within 20 km radius from BHEL with independent premises with communication facilities like telephone and cell phone.
9. All the hiring vehicles should be in white colour. The seats are to be covered with white turkey cloth.
10. The luxury cars should have provision for revolving lamp at top and holder for National Flag.
11. The driver should wear white and white uniform with black shoes.
12. The driver should fill all the details in the trip sheets. Trip sheet for taxis engaged by BHEL will be supplied by BHEL. It is the responsibility of the taxi drivers to get all the columns and each every movement filled and get the entries signed by the user.

13. In case of loss of original trip sheet BHEL reserves the right not to entertain the claim.
14. The driver should keep the valid documents i.e driving license, RC book, insurance cover note, road tax, fitness certificate and valid permit in the vehicle.
15. The cars and vans should be reported in full readiness for the entire trip operation in terms of fuel availability and willingness of drivers.
16. **The starting and closing km readings will be from BHEL Transport section only and it will be certified by the Supervisor-in-charge.**
17. **For Luxury Cars and Non A/C Passenger vans.: Statutory increase/decrease of diesel price will not be compensated. Only accepted rates will be allowed throughout the contract period.**
18. If minimum kilometer is not covered for out-station trip on a single day ( above 300 km) day rent with other claims for night halt, driver batta, extra kilometer for hill road and permit charges will be allowed. Detention charges will not be paid.
19. During the out-station trips, shortest routes should be used otherwise the reason for the same should be furnished.
20. In case of any higher version vehicle supplied in place of lower version, payment will be allowed only for lower version.
21. In case of break-down of a taxi while on operation, the taxi should be replaced by an alternative vehicle within 30 minutes. If the replacement vehicle is not received alternate vehicle will be arranged by BHEL and the extra amount will be recovered from the contractor.
22. For break-down vehicle only fuel charges for running km will be allowed.
23. BHEL reserves the right to extend the validity period of contract for further period at the same rates, terms and conditions applicable to this contract, as mutually agreeable between BHEL and the contractor.
24. For outstation trips driver should be provided with enough money for food, toll charges+ and diesel.
25. The Transport operator should obtain RTO permit for other State trips and fees for Permit charges will be reimbursed on submission of original bills.
26. The actual car parking charges incurred at Airport / Railway Stations/Toll booths and temples will be reimbursed by production of the original receipt without any corrections or over writings.

27. The condition of the vehicle like functioning of air conditioner, condition of tyres, head-lights/indicators, horn, safety belt etc., should be good.
28. Sun film stick in the window glass should not be dark and inner side of the car must be visible for the Security Personnel without lowering the window glass.
29. Driver should have mobile hand set in good working condition.
30. If there is a hand luggage brought by Officials, driver has to come forward and place the luggage in the car.
31. Driver should not demand any money from the user.
32. Taxis shall be reported in pooling section of BHEL Transport in full readiness and cleanliness for the entire day's operation in respect of fuel availability and willingness of the drivers.
33. Taxis should operate only with the "BHEL" name board supplied by BHEL during the time of operation. The boards to be returned every day at the time of trip closing. Else recovery at the rate of Rs 200/- per board will be made.
34. BHEL reserves the right to award the contract to One or More Contractors simultaneously as deemed fit at the initial stage or during the contract period.



## **GENERAL TERMS AND CONDITIONS**

01. Sealed Tenders enclosed for the work are hereby invited from contractors, experienced in works of similar kind and magnitude.

Tenders should be addressed to **The Sr. Manager / M&S/Planning, Bharat Heavy Electricals Limited, Tiruchirapalli- 620 014** the full name and address of the Bidder and the name of the work being noted on the cover with tender Ref.& due date of opening.

02. All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Bidder concerned.

03. Bidders should fill in all the required particulars in the blank spaces provided for this purpose in the tender documents also sign each and every page of the tender document including the drawing attached there to while submitting their tender.

04. Unit rates should be quoted in figures as well as in words with reference to each item and for all the items shown in the attached schedule.

05. Rates for each item of the tender schedule should be quoted in Rupees only. In case any difference in rates quoted to figures and in words, the lower of the rates will be taken as the tendered rate.

- 06. Service Tax as per the Government Norms. Income-Tax will be deducted as per the Rules.**

07. In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the latter case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.

08. Every tender must be accompanied by Deposit receipt for the amount mentioned in this tender notice as Earnest Money Deposit, pledged to BHEL, Tiruvermbur in any of the forms mentioned in para 15 of the General Instructions to bidders (Revised). This Earnest Money Deposit will be refunded to the unsuccessful bidders within 15 days on finalizations of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work in accordance with clause 16 of the General Conditions of contract as amended up to date.

Note : "Cheque, Currency Notes or Money Order will not be accepted in lieu of the Deposit Receipt referred to above".

#### 09. EARNEST MONEY DEPOSIT:

The Earnest Money Deposit Rs 50,000/ ( Rs. Fifty Thousands only ) is to be furnished in any of the following forms:

2. EMD shall not carry any interest.

#### 10. SECURITY DEPOSIT:

1.1 The amount of security Money to be deposited for proper fulfillment of the contract will be as follows:

- Up to Rs. 10 lakhs: 10%
- Above Rs. 10 lakhs up to Rs.50 lakhs: Rs.1 lakh + 7.5% of the amount
- exceeding Rs. 10 lakhs.
- Above Rs. 50 lakhs: Rs 4 lakhs + 5% of the amount exceeding Rs. 50 lakhs.

The security Deposit should be collected before start of the work by the contractor

1.2 The contractor whose tender may be accepted shall, within seven days of receipt by him of the notification of acceptance of his tender, deposit with BHEL, Unit: Tiruverumbur, the prescribed sum as per Clause 16 (i) above towards Security Deposit.

- a. Cash (as permissible under the Income Tax Act), Pay order or Demand Draft in favour of BHEL.
- b. Local cheques of scheduled banks, subject to realization.
- c. Securities available from Post offices such as National Savings Certificates, KisanVikasPatra etc. (Certificates should be held in the name of the contractor furnishing the security and duly pledged in favour of BHEL, Trichy and discharged on the back).
- d. Bank Guarantee from Nationalized, scheduled Banks / Public Financial Institutions as defined in the Companies Act subject to a maximum of 50% of the total security deposit value. The balance 50% has to be remitted either by cash or in the other form of security. The bank guarantee format should have the approval of BHEL.
- e. Fixed Deposit Receipt issued by Scheduled Banks / Public Financial Institutions as defined in the Companies Act . The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back.
- f. Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit will be collected before start of the work and the balance 50% may be recovered from the running bills.
- g. EMD of the successful bidder shall be converted and adjusted against the security deposit.

NO INTEREST SHALL BE ALLOWED ON SECURITY DEPOSITS. BHEL, shall not be responsible for any loss of securities due to liquidation or any other reason whatsoever or any depreciation in the value of the Securities while in their charge or for any loss of interest thereon.

**NOTE:** Acceptance of Security Deposit against Sl. No. (iv) and (vi) above will be subject to hypothecation or endorsement on the documents in favour of BHEL. However, BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith.

- 1.3. All compensation or other sums of money payable by the contractor to BHEL under the terms of this contract or under any other contract with BHEL, may be deducted from the Security Deposit or realized by the sale of the securities or from the interest arising there from or from any sums which may be due or may become due to the contractor payable by BHEL, on any account whatsoever against this contract or any other contract with BHEL and in the event of his Security Deposit being reduced by reason of such deductions or sale as aforesaid, the Contractor shall within seven days thereafter make good in cash or in securities endorsed as aforesaid, any sum or sums by which the security Deposit has been so reduced.
  - 1.4. Security Deposit may be refunded on completion of the work on submission of No Due Certificate.
11. Unless the Contractor, whose tender is accepted, signs the contract agreement within seven days (7 days) of the date of the order directing him to do so, the amount of Earnest Money Deposit already deposited by him will be forfeited and acceptance of the tender withdrawn.
  12. After opening of tenders, a bidder revokes his tender or increases his earlier quoted rates or after acceptance of his tender does not commence the work in accordance with the instructions, the Earnest Money Deposited by him will be forfeited and acceptance of his tender withdrawn. In only, a part of the work included in the tender withdrawn. In only, a part of the work included in the tender has been awarded to the bidder and the bidder refuses to take up the work the amount of Earnest Money to be forfeited will be based on the value of the contract so awarded.
  13. The BHARAT HEAVY ELECTRICALS LIMITED, reserve the right to reject any or all the tenders received or accept any tender or part thereof without assigning any reason therefore. In the case of acceptance of the part of tender, time for completion may also be reduced to the extent considered appropriate by the accepting officer.
  14. Tenders not submitted on the prescribed forms are liable to be rejected.

15. Tenders submitted by Post should be sent by “ Registered Post with Acknowledgement Due”. These should be posted with due allowance for any delay in postal delivery. Tenders received after the due date of opening of tenders are liable to be rejected.
16. The Contractor’s responsibility under this contract shall commence from the date of work order.
17. If a bidder expires after the submission of his tender or after the acceptance of his tender, the BHEL may at their discretion cancel such tender.
18. If the bidder deliberately gives wrong information in his tender BHEL, reserve the right to reject tender at any stage.
19. The general and Special Conditions of Contract are complementary to each other and where they are in conflict, the special conditions shall prevail.
20. Bidders shall not increase their quoted rates, in case the BHEL, negotiable for reduction of rates. Such negotiations shall not amount to cancellation or withdrawal of the original offer and the rates originally quoted shall be binding on the tenders for the period of three months from the date of opening of tenders.
