Additional Requirements

- a. Bidder has to furnish details of the crane i.e. Complete specifications, make, model along with load chart and range diagram of the proposed crane to be deployed for the tendered job (Relevant documents in support of all the above shall be submitted by the bidder).
- b. The age of the offered cranes should not be more than 20 years on the latest due date of tender opening, with respect to year of manufacturing. Necessary documents in support of year of manufacturing of cranes shall be enclosed in the technical bid. Bidder must also furnish Insurance coverage details of the crane.
- c. The bid shall be evaluated based on the above conditions also and the bid is liable to be rejected on account of non-submission of documents satisfying above conditions.
