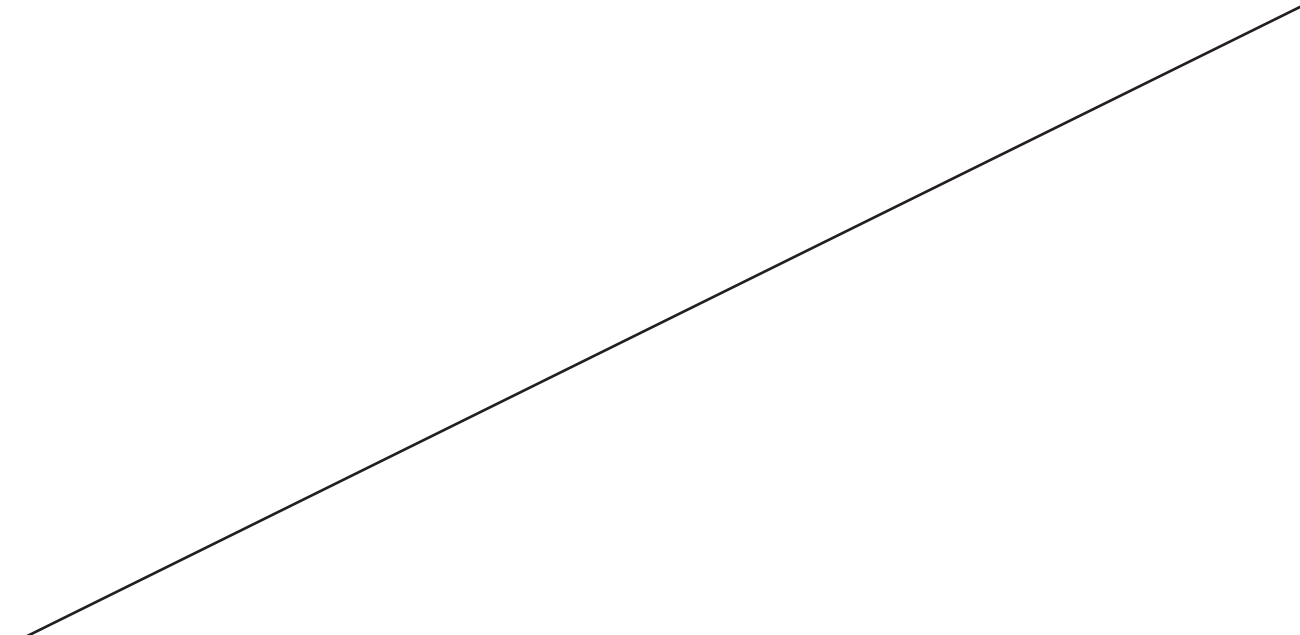
ITEMS : Electrical Lab Equipment

1	Vendor can be either OEM (Original Equipment Manufacturer) or Supplier of Electrical Lab equipment.
2	Vendor should have supplied Electrical Lab equipment to process plant/ refinery/ power plant/ nuclear plant / testing Lab.
3	Vendor should be in business of supplying electrical lab equipment for at least last two (2) years from the date of techno commercial bid opening.
4	Minimum two nos. purchase orders for electrical lab equipment shall be submitted which should not be more than 5 years old from the date of techno-commercial bid opening for establishing continuity in business.
