 - C. Bottling plant to deliver 400 nos cylinders per day.
 - D. Cylinder must be each of approx. 7 CuM capacity.
 - E. Bidder shall follow the applicable latest National /International standards and must submit a certificate mentioning the standards with year and date which he has followed.
2. The oxygen is to be supplied for a period of 24 months as per specification and requirement mentioned above.
 3. Further extension beyond 24 months period, shall be carried out as per the mutual agreed terms and conditions between BHEL and bidder.
