Explanatory note:</b> iv) In the event of bidders shortlisted against Technical and Financial Qualification criteria not meeting the criteria on 'Assessment of Capacity of Bidders' detailed above leads to situation where number of shortlisted bidders is less than four, BHEL at its discretion reserves the right to reconsider the bidders who meet the Technical and Financial Qualification Criteria in the following manner: a) Consider the bids if the Overall Performance Rating ( <b>'R<sub>BHEL</sub>'</b> ) is <b>≥60</b> , irrespective of their loading for further processing of the Tender. b) Consider the bids of all the <b>"First timer"</b> bidders if the Average performance score is <b>≥60</b> , irrespective of the number of scores available till the Cut Off month as defined in "II". c) Consider the bids of all the <b>"First timer"</b> bidders having no performance score because of work not started till the Cut Off month as defined in "II". d) Option "b" as above shall be considered <b>ONLY</b> for situation where number of shortlisted bidders is less than four even after considering option "a" as above. e) Option "c" as above shall be considered <b>ONLY</b> for situation where number of shortlisted bidders is less than four even after considering option "a" and "b" as above.
