1.0 Introduction

Bharat Heavy Electricals Limited (BHEL) is a Maharatna public sector Enterprise under the administrative control of the Ministry of Heavy Industries. It has the distinction of being the India's largest power plant equipment manufacturer. The company has its corporate and registered office in Delhi and has a network of 16 manufacturing units, 2 repair units, 4 regional offices, 8 service centers, 15 regional centers. BHEL is supplier of a wide range of products, systems and services for the core sectors of the economy, viz. power, transmission, industry, transportation, renewable energy, oil & gas and defense. Further details about the company and its operations can be obtained from its website www.bhel.com.

1.1 Objective of EOI

One of the units of BHEL at Haridwar, Heavy Electrical Equipment Plant (HEEP) is having its own Private Railway Siding at its premises established for its own material handling. BHEL intends to develop this siding as Brownfield Private Freight Terminal (PFT) & for this BHEL is looking for shortlisting of PFT operators having experience of running PFT/ICD businesses besides marketing expertise of these services. Indian Railways is promoting the concept of development of Private Freight Terminals (PFT) on existing railway sidings or at a new place and had issued circular No. 2018/TC (FM)/14/04 dated 23.06.2020, of this intent followed by subsequent amendments. As BHEL intend to develop Private Freight Terminal (PFT) for which an **Expression of interest is being invited by BHEL Haridwar** from the interested existing players of this sector as per following terms and conditions. The processing of EOI shall be used to identify the interested eligible parties who make a Bid in accordance with the provisions of this EOI.

1.2 Current Business Scenario

The opening of the Freight Terminal Services for private sector by Railways in Jan, 2015 have triggered rapid country wide development of PFT in India & already approximately 79 PFTs are operating in various parts of India. After development of the new state of Uttarakhand, Haridwar and surrounding districts have seen massive industrial growth and road network is not adequate to cater their total transportation requirements. A number of industries & SIDCUL associations are already approaching Railways for developing PFT in the state. The presence of large number of medium to big industries in SIDCUL Haridwar, Bhagwanpur and Dehradun etc. is expected to be a big driver in demand for PFT.

Note: Term PFT shall be known and referred as "Rail Based Logistics Terminal (RBLT)" here and after

1.3 Existing Facility

BHEL, Haridwar is having its own Private Railway Siding at its premises. This siding is stationed at about 4 Kms from Haridwar Railway Station. The Railway siding is surrounded with adequate land bank and two-way road connectivity. We have also four yard lines measuring 700-750 Mtrs beside main line. A tentative layout of the proposed RBLT is enclosed at Annexure – D.

Existing two-way road in the vicinity of BHEL Railway siding is available for connectivity up to siding. BHEL reserve the right to restrict the movement of PFT related vehicles on other roads of its township and may form guidelines time to time for road movement so that the traffic nuisance on the roads can be minimized.

1.3.1 Business Model for RBLT:

1.4 **Broad Scope of Work:**

- 1.4.1 To develop Terminal (all related civil, electrical and other works)
- 1.4.2 Take legal & administrative approvals/licenses as may be applicable for development of RBLT & running RBLT business.
- 1.4.3 To run RBLT related business with own resources and as per contractual terms & conditions.
- 1.4.4 Expenses of regular/ day to day maintenance of the terminal will be borne by the operator.
- 1.4.5 To carry out marketing for RBLT.
- 1.4.6 Regular interaction & information sharing with BHEL as per the mutual agreed modalities.
- 1.4.7 RBLT operator shall have to restrict their operations within clearly identified & marked area.

2.0 EOI Process:

- **2.1 Technical Bid:** It shall contain all the relevant information, documents/ reports conferring qualifying criteria as per clause no. 3.1 Bidder has to submit clear and adequate documents in support of their qualification and other requirements. Each and every page of the same must be signed by duly authorized representative.
- **2.2** The bid shall contain the estimated CAPEX expenditure for the development of RBLT as per Annexure-E. The infrastructure developed has to be in accordance with Railways PFT construction guidelines.

Evaluation Criteria:

All the bidders will be evaluated in the following manner:

Technical Evaluation: Technical bids of the bidders will be evaluated in accordance with following criteria:

Technical bids will be evaluated as per clause no. 3.1. On fulfilling all the qualifying requirement, bidders will be shortlisted for further process of tendering by BHEL or any other process as may be deemed necessary by BHEL.

3.0 <u>Bid and Documents to be submitted:</u> Bidder is required to submit all the document online and which shall be clear and adequate in support of their qualification and other requirements. Each and every page of the same must be signed by duly authorized representative.

Incomplete bid document may not be considered and can be rejected.

3.1 QUALIFYING REQUIREMENTS: The intending bidder shall fulfill the following criteria:

- 3.1.1 Bidder who is submitting EOI should have one PFT/ICD registered in its name and valid as on date. Bidder should also have minimum five years of operating experience of at least one PFT/ICD as on date of issue of EOI. Bidders also have to submit Performa for performance statement as per Annexure- B.
- 3.1.2 Bidders can be a Sole Proprietor/company/Firm/JV Company or Group of Entities ("GOE").
- 3.1.3 The Business tie-up agreement would be entered into by the BHEL with the single entity Bidder or the lead member of the GOE.
- 3.1.4 The Bidders must be of financial soundness and must have achieved average annual turnover of at least Rs. 10 Crores during last five financial years in PFT/ICD business.
- 3.1.5 The Bidder should have positive Net worth in any three out of last Five financial years. This will be judged from audited financial data of last five financial years.
- 3.1.6 Bidder should have earned operational profit in at least one financial year during last three Financial years ending 31-03-2022 in PFT/ICD business.
- 3.1.7 In case of joint bidding, an undertaking is required to be submitted by all the partners of GOE that they are joining together to meet the scope of the EOI. The Bid should include a brief description of the roles and responsibilities of individual members. The undertaking must clearly indicate one of their members as the lead member of the GOE. The lead member of the GOE would be responsible to BHEL for the entire scope of work and shall ensure back to back tie ups with other members of the GOE.

3.2 Compulsory Documents to be submitted: The Bidder has to submit following documents along with Bid:

- 3.2.1 Letter comprising the Bid as per format enclosed at <u>Annexure A</u> along with information, data & supporting documents thereof.
- 3.2.2 Documents fulfilling qualifying requirements in 3.1.
- 3.2.3 Copy of Articles & Memorandum of Association or partnership deed or any other applicable document as proof of registration of entity.
- 3.2.4 Copies of Income Tax Returns along with duly audited balance sheets and profit and loss accounts for the Five financial year's i.e. 2017-18, 2018-19, 2019-20, 2020-21 & 2021-22.
- 3.2.5 Copy of Permanent Account Number.
- 3.2.6 Copy of GST Registration.
- 3.2.7 Copy of PFT/ICD notification issued from Railway/Custom department as the case may be.
- 3.2.8 Brief profile of the company & their management team.
- 3.2.9 Estimated CAPEX requirement for the stated infrastructure at Annexure-E to be submitted with details with mention of references/ standard/quidebook etc.

Note: All the documents should be duly signed by Authorized signatory. The Authorized signatory shall be the person holding "Power of Attorney" on behalf of the firm /company/Bidders concerned and properly authorized / empowered to act on behalf of the Bidders for the specific purpose. In case of proprietorship entity, only the proprietor or an individual holding POA may signs the documents. Whereas in case of partnership firms, the documents must be signed by all the partners of the firm or by a person holding valid POA on behalf of other Partners. Notarized copy of such POA shall be submitted along with the quotation.

4.0 General Instruction to the Bidders:

4.1.1 Uploading of EOI

EOI shall be uploaded online at https://bhel.com/tenders and https://bhel.com/tenders/onlinetenders/. Interested bidders may download documents from above mentioned sites.

4.1.2 Submission of the Proposal:

During scrutiny of EOI Bids, BHEL may invite parties for further clarification/ deliberations. BHEL reserves the right to request such information from any or all of the interested party (ies) and such party will be obliged to respond within the time as stipulated.

4.4 EOI Pre-bid meeting:

4.4.1 On 06.06.2022 a pre-bid meeting is proposed to be held from 2:00 PM to 4:00 PM at GM (HR) Conference Hall, BHEL Haridwar for discussions on the EOI, any changes in schedule will be posted on https://bhel.com/tenders and https://bhel.com/tenders/onlinetenders/. Bidders may visit BHEL rail siding on the day of pre-bid meeting.

4.5 BHEL Statement of Rights/Prerogative.

- 4.5.1 BHEL reserves the right to annul the EOI Process and reject all Bids, at any time without any liability for such annulment, and without assigning any reasons thereof.
- 4.5.2 BHEL reserves the right to proceed with/ cancel the process irrespective of the response to its invitation.
- 4.5.3 Updates with respect to EOI shall be hosted on https://bhel.com/tenders and https://bhel.com/tenders/onlinetenders/ only.
- 4.5.4 Without limiting the generality of the foregoing, BHEL reserves the right to reject any or all of the Bids submitted, whether or not complete and whether or not it contains all the required information.
- 4.5.5 Decision of BHEL management in respect of the above would be final and binding on the Bidders.
- 4.5.6 BHEL may, in its sole and absolute discretion, independently verify any information in any submission. Any such verification or lack of such verification by BHEL shall not relieve the Bidder of his obligations or liabilities.
- 4.5.7 This EOI does not create a tender process. EOI will be evaluated by company designed processes.

4.6 General Terms & Conditions:

- 4.6.1 The Bidder should satisfy himself that document is complete in all respects. The Bidder should contact the competent authority at BHEL Haridwar and verify facts in case of ambiguity in interpretation of EOI document, before submission of EOI.
- 4.6.2 Mode of EOI evaluation shall be final and binding to all Bidders. BHEL shall not entertain any correspondence in this regard.
- 4.6.3 Mere participation & qualification in EOI will not automatically mean that such Bidders are considered qualified.

4.7 Indemnity to BHEL:

The RBLT operator shall be required to indemnify BHEL adequately from all legal, financial and statutory obligations arising out of PFT business i.e. starting from development to operations etc. as may be deemed appropriate by BHEL.

4.8 Jurisdiction/Arbitration:

All matters relating to the EOI and selection of Interested Bidder and the bidding procedure shall be governed by the laws of Union of India. Only Courts at Haridwar, Uttarakhand (India) shall have exclusive jurisdiction to decide or adjudicate on any matter, which may arise out of or in connection with the EOI process.


