Bidders to kindly take note of the following:

AA) Issue of Clarification.

<u>QUERY 1</u>: SCOPE FOR MOBILISATION & DEMOBILISATION (SCC VOLUME 1A, S. No. 13) – As per tender, it is in vendor's scope. It is being brought to notice that it is not at all practical & commercially feasible. The plant is operated by NTPC and BHEL is carrying out the R&M work. BHEL may have suitable capacity cranes available at site whereas contractor may need to mobilize the same. Typically, the requirement is of a Hydra crane and a 80-100 MT mobile crane for a period of approx. 7 days. For such a short duration of hire, the per day hire charges will end be high. Moreover, contractor may even have to mobilize the crane from outside which will be an even more costly affair and will result in higher cost. In the interest of keeping costs low, it is suggested that this should be in BHEL scope.

CLARIFICATION 1: Recommendation of bidder is noted. However, the tender conditions stand as it is.

<u>QUERY 2</u>: TOTAL AMOUNT PAYABLE TOWARDS MOBILIZATION/DEMOBILIZATION (TCC VOLUME 1A, 1.1.19) AND DISMANTLING, LOCAL SHIFTING AND RE-ERECTION (TCC VOLUME 1A, 1.1.21) – To note that a 20 MT tower crane needs to be transported in 12 trailers and the mob/demob charges mentioned in the tender at present do not sufficiently cover the expenses of transporting the tower crane to and from the site. Further, erecting and dismantling a 20 MT tower crane is a very cumbersome process and it shall need to deploy huge manpower for a period of at least 30-45 days for each instance of erection, dismantling or shifting. During this period, it shall also be needed to arrange for their accommodation and transportation. In addition, it is required to engage OEM engineers at additional cost. So it is suggested to re-consider the issue.

CLARIFICATION 2: Recommendation of bidder is noted. However, the tender conditions stand as it is.

<u>QUERY 3</u>: ELECTRICAL POWER REQUIREMENT TO OPERATE THE CRANE (TCC VOLUME 1A, S. No. 1.1.12) -This can cause problems and issues at site during installation of the tower crane. It is requested to kindly ensure that power is provided by BHEL upto the main power board of our tower crane.

CLARIFICATION 3: Recommendation of bidder is noted. However, the tender conditions stand as it is.

<u>QUERY 4</u>: TECHNICAL DETAILS OF TOWER CRANE (APPENDIX 1, S.No. 18) – As per this clause, the vendor shall have to carry out all related work for foundation. This is in direct conflict with TCC Volume 1A, S. No. 1.1.2 where it is mentioned that foundation (if required) will be provided by BHEL.

CLARIFICATION 4: Recommendation of bidder is noted. The clarification/amendment to the clause is as follows:-

Further, it is mentioned that the L-1 rate shall be calculated as landed cost to BHEL (including cost of foundation). Therefore, the reverse auction process for each vendor will need to be entered as their price bid + their foundation cost as communicated by BHEL. Please confirm.

<u>CLARIFICATION 5</u>: Request of bidder is noted. The no. of locations for erecting tower crane planned for 6x210MW ESP structure shall be Three (03) nos. (which means two shifting). Similarly, the no. of locations for erecting tower crane planned for 2x500MW ESP structure shall be One (01) no.
