5.	<p><b>Warrantee /Defect Liability :</b></p> <p>The equipment / material supplied and services rendered (if applicable) shall be warranted to be free from all defects and faults in design &amp; engineering, material, workmanship &amp; manufacture and in full conformity with the Purchase Order / Contract, Technical Specifications &amp; approved drawings / data sheets, if any, for 60 (sixty) months from the date of taking over (ie 26.09.18) by end customer or <b>date of delivery at site, whichever is later.</b></p> <p>For the purpose of this clause, the measurable defects as per technical specification shall also be considered.</p> <p><b>Note A</b> :-If the facilities or any part thereof cannot be used by reason of such defect and/or making good of such defect, the defect liability period of the facilities or such part, as the case may be, shall be extended to above mentioned period by a period equal to the period during which the facilities or such part cannot be used by the customer because of any of the aforesaid reasons.</p> <p><b>Note B</b> : Upon correction of the defects by repair/replacement, such repair/replacement shall have the Defect Liability Period of said equipment (Auto Transformer), extended by a period of 2 years from the time of such repair/replacement of said equipment (Auto Transformer) to rectify the defect, or upto the expiry of Defect Liability period mentioned above, whichever is later.</p> <p>The defective material / component shall be repaired / replaced free of cost at site. Freight &amp; Insurance during transit shall also be in the scope of the supplier / contractor. Any expenditure for dismantling and re-erection of the replaced equipment / material / component shall be to supplier's / contractor's account. All replacements during the warrantee period shall be delivered at site promptly and satisfactorily within a period not more than 45 days from the date of reporting the defect / rejection etc.</p> <p>In the event of the supplier / contractor failing to repair / replace the defective equipment / material / component within the time period mentioned above, BHEL may proceed to undertake the replacement of such defective equipment / material / component at the risk and cost of the supplier / contractor without prejudice to any other rights under the contract and recover the same from PBG / other dues of this Purchase Order / Contract or any other Purchase Order / Contract executed by the supplier / contractor.</p> <p>Note :</p> <p>i) In addition to the above guarantee period, Extended Guarantee / Warranty, if any, shall be as per NIT / Technical Specifications.</p> <p>If it becomes necessary for the supplier to replace or renew/rectify any defective portion of the plant/defective work executed under this clause, the provision of these clause shall be apply to the portions of the plant so replaced or renewed/rectified.</p>

In case there are delays of submission /resubmission of drawing /documents as per above schedule, that much days would be reduced from deliver period.</b></p> <p><b>Mandatory spares are to be delivered along with the last consignment of main supply with in the contractual delivery period.</b></p> <p><b>Note: Date of receipt of material at site, shall be considered as delivery date.</b></p>
