The Corrigendum contains following amendment in the specifications and shall be a part of the above tender. This corrigendum is to be submitted, duly signed and stamped, along with the technical bid (Part –I).

1.0) Clause No. 28 d) Micro and Small Enterprises (MSE) of Notice Inviting Tender shall be modified as below

d)	Participating MSEs quoting price within price band of L1+15 % shall be considered for award of complete scope of work by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE. In case of more than one such MSE, MSE with lowest price shall be given the first option to match the L1 price. However, MSEs owned by the Scheduled Caste or the Scheduled Tribe entrepreneurs shall be given the preference for matching the L1 price irrespective of their standing in comparative statement of MSE bidders within price band of L1+15 %.	Participating MSEs quoting price within price band of L1+15 % shall be considered for award to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE. Such MSE shall be allowed to supply upto 20 % of total tendered quantities. In case of more than one such MSE, MSE with lowest price shall be given the first option to match the L1 price. However, a quantum of 4% out of 20% so earmarked will be reserved for MSEs owned by the Scheduled Caste or the Scheduled Tribe entrepreneurs quoting price within price band of L1+15 %. This clause is applicable for Service contracts only. Service for this purpose means any subject matter of procurement other than materials or works and includes physical, maintenance, professional, intellectual, consultancy and advisory services or any other service classified as such.

2.0 All other terms and conditions against this NIT shall remain unchanged.
