(B) TECHNICAL DELIVERY CONDITION:

- 1. MATERIAL SHOULD BE AS PER SPECN. AA19511/09.
- 2. 6 TO 8 mm MACHINING ALLOWANCE IS REQUIRED ON TOOL POINTS.
- 3. TOLERANCE ON UN M/CD CASTING SURFACES IS TO BE MAINTAINED AS PER TOLERANCE CL.4 OF STD. AA0230402.
- 4. DIMENSIONS REPORT IS REQUIRED.
- 5. ROUGH M/CD CASTING TO BE SUPPLIED AS PER TDC-BA75020 REV.02.
- 6. AFTER ROUGH M/CING, CASTING SHALL BE SUBJECTED TO UT, DP AND MPI TEST AS MENTIONED IN QAP.
- 7. CASTING SHOULD BE FREE FROM ALL DEFECTS.
- (C) TEST CERTIFICATE: REQUIRED FOR CHEMICAL AND MECHANICAL PROPERTIES, UST, DP AND MPI TESTING OF CASTING.
- (D) GUARANTEE CERTIFICATE: REQUIRED FOR 12 MONTHS AGAINST ANY MANUFACTURING DEFECTS.
- (E) PACKING INSTRUCTION: ITEM TO BE SUPPLIED WITH 1 COAT OF ZINC PHOSPHATE PRIMER ON UN MACHINED SURFACES AND TRP PAINT ON MACHINED SURFACES.
