3	Location	The proposed site is at a distance of about 4 km from Talcher town and about 25 km from district headquarters Angul in Odisha state, India.
4	Nearest Railway Station	Talcher is on Talcher-Cuttack section of North Eastern Railway (renamed East Coast Railway) at about 2 Km.

4.0 Broad scope of work:

BHEL is in requirement of Land for material storage activity.
Details of Required Land is mentioned hereunder:

1.	Area of Land	Minimum 75 Acres & Maximum upto 100 Acres
2.	Duration	5 (Five) Yrs.
3.	Location/Proximity	Within approximately 25 Km from Plant main gate, 2X660 MW Talcher Thermal Power Station, Dist-Angul, (Odisha) PIN - 759107
4.	Other Requirements	Land must be free from all Encumbrances. Land should not be in Low lying area. Land must be well connected with main road. Land to sufficiently developed and levelled.

5.0 Utilisation of Land:

1. The selected land (herein after mentioned as Land) shall be utilised as Material Storage facility.
2. BHEL/its agency shall develop the land to its use and shall execute some civil activities (including excavation, development of Roads and drains, laying of culverts, hard crusting of surface etc.)

3. BHEL/its agency shall also make arrangement for area lighting.
4. In case area fencing not done, BHEL/its agency shall fence the area.
5. BHEL/its agency shall develop temporary structure such as security cabins/office.
6. BHEL/its agency shall develop Water and Electricity arrangement.
7. BHEL/its agency may erect material storage shed.
8. BHEL/its agency may develop material weighment arrangement.
9. BHEL/its agency may modify or adapt the land to suit the purposes

Note: Vehicles with heavy consignment shall be moving into the storage area for Material Handling activities.

6.0 Maintenance of Land:

1. From the date of Lease Agreement, General Maintenance of land shall be in the scope of BHEL.
2. BHEL shall pay the cost of all utility services during the Lease Duration, including but not limited to initial connection/installation charges and all charges for water, electricity etc. used on the Leased Premises.

7.0 Termination of Lease:

1. The lease agreement may be terminated by BHEL, before completion of lease duration, by giving due notice of 30-60 days to the land owner.
2. On Termination of Lease agreement, BHEL shall clear the land from all superstructures and materials, at its own cost.

8.0 Tools and Plants:

All T&Ps required for establishment and dismantling of storage shed shall be in the scope of BHEL.

9.0 Schedule for Completion of work:

5(Five) Years from the date of Lease Agreement. The Lease may be extended further on mutual agreement basis.

10.0 Terms of Payment:

1. One month rent shall be paid as advance within 7 days from the date of Contract agreement.
2. Agreed monthly rent shall be deposited by BHEL on due date, with a grace period of 5 days.

7. If transfer of land has happened through multiple owners, entire lease documents needed.
8. Genealogical table (Vanshawali) issued by Panchayat.
9. Undertaking from owner that no litigation or court cases are pending.
