### **GOUGING ELECTRODE FOR USE IN FOUNDRIES**

#### 1. General:

This specification covers the requirement of non-jointed type gouging electrodes for use in Steel Foundry.

#### 2. Application:

The gouging electrode will be used for removal of metal/localized defects from casting maintained in temperature range of 30°C to 350°C with the help of Gouging arc holder.

#### 3. Compliance with national standard:

There is no national standard available for this item.

#### 4. Properties:

4.1 Size: Diameter 9 mm X length 350 mm / 450 mm
Diameter 12 mm X length 350 mm / 450 mm
Tolerance on Diameter shall be +1 mm /-0.2 mm and on length will be +10 mm /-2 mm.

4.2 Bulk density: 1.55 - 1.75 gm/cc without copper coating.

1.80 - 2.20 gm/cc with copper coating.

Difference in density with & without Cu coating shall be minimum 0.20 gm/cc. Bulk density will be measured by physical measurement method in which diameter will be taken by vernier caliper or screw gauge for both serrated & non serrated electrodes.

- 4.3 The gouging electrodes shall have uniform Cu coating & may be smooth or serrated finish. The Cu coating shall not have any crack/discontinuity.
- 4.4 Specific Resistance at RT:  $2.5 \times 10^{-3}$  ohm-cm max. without copper coating.  $4.0 \times 10^{-4}$  ohm-cm max. with copper coating.
- 4.5 The carbon shall not disintegrate during gouging operation.

4.6 Chemical Composition: Fixed Carbon content: 98% minimum

Ash: 2% maximum

- 4.7 Electrode should be able to work with air pressure of 5-8 kg/cm<sup>2</sup>.
- 4.8 Electrode should be able to work upto 900 A & 600 A (DCEP) respectively for 12mm & 9mm dia.
- 4.9 The copper coating shall not flake or peel off during use at rated amperage. The electrode shall not split or crack while in use.


