- 2. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar

- proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 3.Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
