- i) Three similar completed works each costing not less than Rs 26 lakhs.

OR

ii) Two similar completed works each costing not less than Rs.32 lakhs.

OR

- iii) One similar completed work each costing not less than Rs 51 Lakhs
- c) Vendor should have earned profit in at least one year during last three financial years ending on 31.03.06
- d). The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.

NOTE: Similar job shall mean successfully executed/executing erection, testing and commissioning of complete substations of 220 KV and above ratings including Power Transformer.

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders.
