

PRE- QUALIFICATION REQUIREMENT FOR BIDDERS FOR 3 X 800MW NTPC PATRATU TPS

WAGON TIPLER, SIDE ARM CHARGER & APRON FEEDER MACHINE PACKAGE

(I) TECHNICAL PQ CRITERIA

The bidder is required to **meet the provenness criteria and qualification requirement** for the **Wagon Tippler, Side arm charger & Apron Feeder machine** as per the stipulated criteria indicated in the respective clauses listed below for the purpose of qualification of Bidder's techno –commercial bid.

A.	<u>Pre- Qualification requirement for Wagon Tippler, Side arm charger & Apron Feeder machine</u>
A.1	The Bidder should have designed, manufactured, supplied, erected and commissioned including associated electrical works minimum one (1) no. of side discharge wagon tippler suitable for tipping Indian Railway Wagons used for transportation of coal or other minerals which should have been in successful operation for at least one (1) year as on 7th September 2018.
A.2	Bidder should have designed, manufactured, supplied, erected and commissioned at least one (1) no. of Side arm charger for hauling rake of minimum 58 loaded wagons, which should have been in successful operation for at least one (1) year as on 7th September 2018.
A.3	Bidder should have designed at least one (1) no. of rota side wagon tippler suitable for tipping 25 tips/hour of Indian Railway wagons as per latest RDSO guidelines and got it approved by end customer or his consultant, as on 7th September 2018.
A.4	The Bidder should have designed, manufactured, supplied, erected and commissioned including all associated electrical works at least one (1) number Apron Feeder with rated capacity of 1000 Metric tonnes per hour (or above) for coal or other mineral of equivalent volumetric capacity which should have been in successful operation for at least one (1) year as on 7th September 2018.
A.5	Bidder to note that the acceptance of the offer is subjected to the "VENDOR approval from our customer NTPC/PVUNL" and BHEL reserves the right to reject offer of any bidder based on their poor/non-performance in past / present projects/ orders.

(II) FINANCIAL CRITERIA

Bidder should have an average turnover of **Rs. 15 Crores** during last three financial years ending 31st March 2022 and should submit audited balance sheets, Profit & loss accounts. Annual reports of FY 2019-20 , FY 2020-21 & FY 2021-22 are required to be submitted.

NOTES:

1. Bids will not be considered for evaluation if Bidder is blacklisted/ banned/ hold as on date of bid opening by any PSU or Government agency in India.
2. Bidder shall submit requisite Documentary evidence such as attested copy of award letter/ contract and also completion certificates/ performance certificates of previous works executed with aforesaid criteria, properly indexed along with offer.
3. Bid documents are to be only in English language. The bid supporting documents other than in English language are also to be supported with translated document in English language. Translated document shall be endorsed by Indian embassy of document originating country.
4. **Bids under technical collaboration / consortium for this package is not allowed .**
