Scope of Work:	Design, detailed engineering ,submission of drawings for approval , manufacturing, inspection and testing at manufacturer's works, proper sea-worthy packing and forwarding of LT XLPE POWER CABLES as mentioned in the specification.

1	Pre-Qualification Requirement: (Technical)
1.a	The bidder should have manufactured and supplied at least hundred (100) Km of XLPE insulated PVC sheathed power cables of 1 KV or higher voltage grade in one single contract. The references provided to be before 22-9-15 .
1.b	The bidder should have manufactured and supplied at least ten (10) Km of flame retardant low smoke (FRLS) cable. The references provided to be before 22-9-15 .
1.c	Manufactured and supplied at least ten (10) Km of 1kV or higher-grade power cable of minimum 630sq.mm conductor size. The references provided to be before 22-9-15 .
	<p>Bidder to clearly establish requirement 1.a ,1.b and 1.c with Purchase order copies and corresponding self-attested invoice copies</p> <p>The Bidder to provide credentials in terms of Organization Setup, Product and Service Range, Details of Key Personnel, List of Plants & Machinery, Facility for testing & Inspection, Certifications available, List of Clients, Complete List of Projects Executed (year-wise) clearly mentioning the Scope of work.</p> <p>Bidder to confirm availability of in-house capability to carry out all routine, type and acceptance test as per relevant IEC standards</p>
2	Pre-Qualification Requirement: (Financial)
2.a	Average Annual turnover of INR 50 crores during last three consecutive financial years (FY 2017-18, 2018-19 & 2019-20) ending 31st March 2020, and should submit Annual reports such as Audited balance sheets of these three years.

NOTE:

1. Bidder to furnish declaration on their letter head for the following.
 - a) Bidder has not been referred to National Company Law Tribunal (NCLT) /National Company Law Appellate Tribunal (NCLAT) /any other similar Government agency in India or Bangladesh for Insolvency and Bankruptcy
 - b) Bidder is not a potentially sick company (Negative net worth)
 - c) Bidder to furnish information (If any) regarding exclusion, expulsion or black listing by any PSU or Government agency in India or Bangladesh
2. If any bidder is black listed or put on hold by any of the BHEL units, such bidder will not be eligible for this tender and their bids shall not be accepted.
3. Bid document shall only be in English language. All the supporting documents/documentary evidences shall be Self-attested.
4. BHEL reserves the right to reject offer of any bidder based on their poor/ non-performance in past/ present projects/ orders.
5. Bidder should submit all the necessary documents to comply with aforesaid criteria. Quotations received from bidders who do not fulfill the PQR shall be rejected without any further evaluation and information to bidders.
