03	Bidder must source raw materials ISMC, ISA, ISMB of approved Make as per attached vendor list (Annexure-III).	hot dip galvanization (Annexure-III). Confirmation of bidder to source raw materials ISMC, ISA, ISMB Make as per approved vendor list (Annexure-III) attached herewith.

Definition of similar item: The similar item shall be the mild steel structure like columns assemblies, beams assemblies, girders, towers, poles, trusses etc. meant for supporting other objects like busduct, cable tray, PV modules, boiler assemblies, bridges etc. fabricated out of ISMB, ISA, ISMC of mild steel conforming to IS:2062 and using general manufacturing processes viz. cutting, bending, welding etc.

General Notes:

- Bidders to submit all supporting documents in English language. If documents submitted by bidder
 are in the language other than English, a self-attested English translated documents should also be
 submitted.
- 2. After satisfactory fulfilment of aforesaid PQ requirements, offer of bidder shall be considered for the further evaluation as per NIT and other terms & conditions of the tender.
- Any other credentials/certifications available with bidder viz. OHSAS 18001, ISO 14001, ISO 50001 / EMS etc. may also be furnished.
- 4. Consideration of offer shall be subject to customer's approval of bidders, if applicable.
