

- 1. Percentage (%) value of Service Charge quoted by the bidder shall remain FIRM during the entire Contract Period of 24 months and will not be subjected to any escalation whatsoever during the currency of this contract. However, the absolute cost may vary as per the bill value on all-inclusive basis.
- 4. Service Charge quoted by the bidder is inclusive of all the payments to the CONTRACTOR's resources, statutory liabilities like labour license, adequate insurance policy, provident fund, Bonus, etc. and any other regulations enforced from time to time, taxes, duties, profits and any other charges (including but not limited to as mentioned herein / after) that may be incurred during execution of this contract.
- 5. The Descriptions mentioned (SI. No.3 to SI. No.6) in Part C of Volume II Price Bid are FIRM and the rates mentioned against each of them are only for illustrative purpose, based on the weighted average of rates applicable at different states, where the cranes are presently available. However, the Minimum wages with VDA and other Statutory components shall be as per the applicable state/central wages of the respective site, where the O&M services is to be provided.
