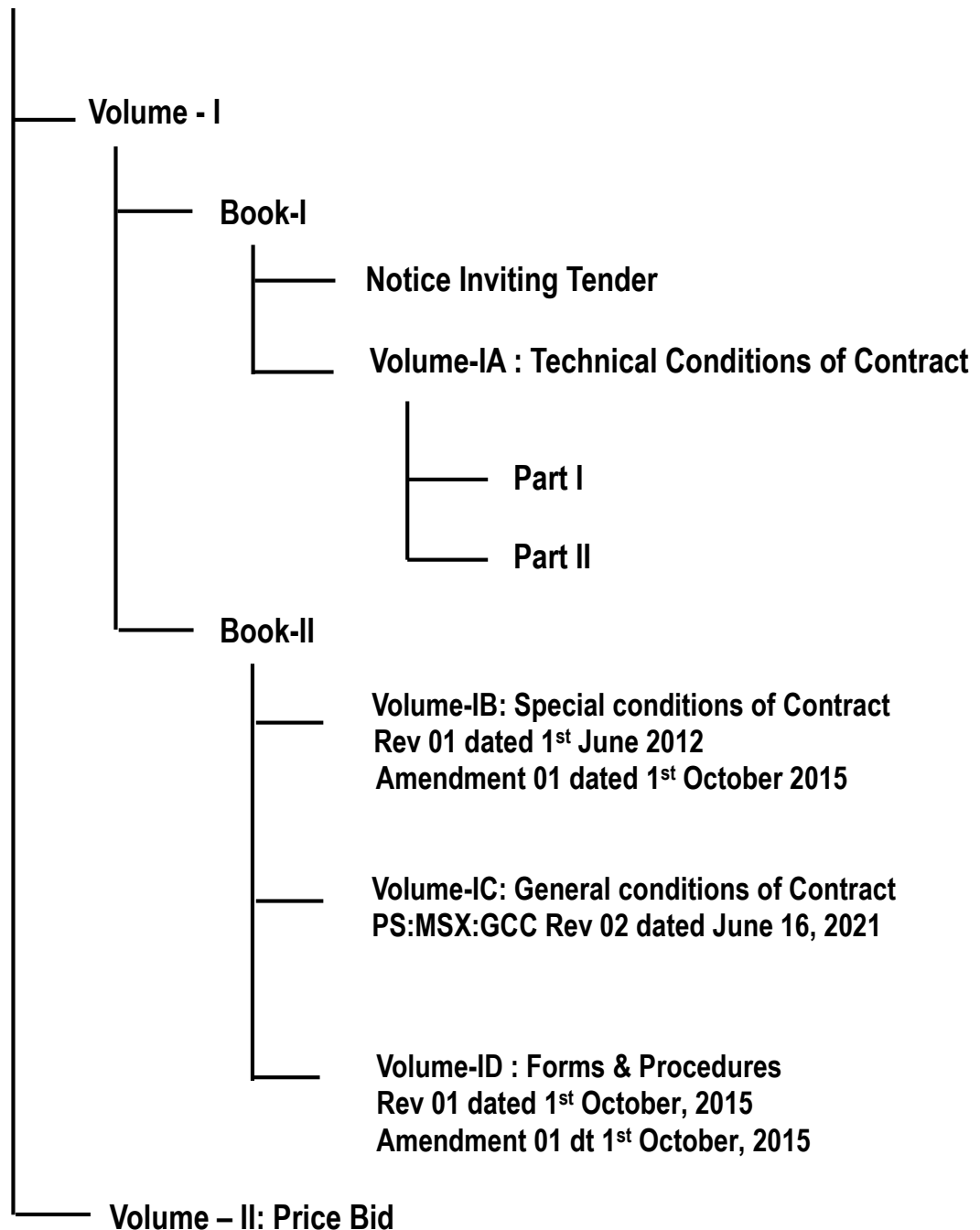

35.4 The ratio of the total amounts for Package 1 and Package 2 shall be 1 and 0.870755 (Explanatory statement: If the total amount of Package 1 is considered as 1, then the total amount of package 2 shall be considered as 0.870755).
