9.0 Assessment of Capacity of Bidders: NOT APPLICABLE

Bidders capacity for executing the job under tender shall be assessed 'LOAD' wise and 'PERFORMANCE' wise as per the following:

I. <u>LOAD</u>: Load takes into consideration <u>ALL</u> the contracts of the Bidder under execution with BHEL Regions, irrespective of whether they are similar to the tendered scope or not. The 'Load' is the sum of the unit wise identified packages (refer Table-1) for contracts with BHEL Regions. The cut off month for reckoning 'Load' shall be the month, two (2) months preceding the month corresponding to the 'latest date of bid submission', in the following manner:

(Note: For example if latest bid submission is in Aug 2011, then the 'load' shall be calculated upto and inclusive of June 2011)

i). <u>Total number of Packages</u>

Total number of Packages in hand = P
Where

- 'P' is the sum of all unit wise identified packages under execution with BHEL Regions as
 of the cut off month defined above, including packages yet to be commenced, excepting
 packages which are on HOLD due to reasons not attributable to Bidder..
- II. PERFORMANCE: Here 'Monthly Performance' of the bidder for all the packages (under execution/ executed during the 'Period of Assessment' in all the Power Sector Regions of BHEL) SIMILAR to the packages covered under the tendered scope, excepting packages not commenced shall be taken into consideration. The 'Period of Assessment' shall be 6 months preceding the cut off month. The cut off month for reckoning 'Period of Assessment' shall be the month two (2) months preceding the month corresponding to the 'latest date of bid submission', in the following manner:

 - c) Sum 'S₁ ' of 'Monthly Performance Evaluation' Scores (S₁₋₁, S₁₋₂, S₁₋₃, S₁₋₄, S₁₋₅,.... S_{1-N}) for similar package P₁, for the 'period of assessment' 'T₁' (i.e. S₁ = S₁₋₁ + S₁₋₂ + S₁₋₃ + S₁₋₄ + S₁₋₅ +...S_{1-N}). ii) <u>Calculation of Overall 'Performance Rating' (RBHEL) in case 'similar Package/Packages' for the tendered scope ARE NOT AVAILABLE, during the 'Period of Assessment'</u>:

This shall be obtained by summing up the 'Monthly Performance Evaluation' scores obtained by the bidder in all Regions for ALL the packages, divided by the total number of Package months for which evaluation should have been done. 'R_{BHEL}-' shall be calculated subject to availability of 'performance scores' for at least.6 'package months' in the order of precedence below:

- a) 'Period of Assessment.
- b) 12 months preceding the cut-off month
- c) 24 months preceding the cut-off month
- d) 36 months preceding the cut-off month

In case, R_{BHEL} cannot be calculated as above, then Bidder shall be treated as 'NEW VENDOR'. Further eligibility and qualification of this bidder shall be as per definition of 'NEW VENDOR' described in 'Explanatory Notes'

III. 'Assessment of Capacity of Bidder':

'Assessment of Capacity of Bidder' is based on the Maximum number of packages for which a vendor is eligible, considering the performance scores of similar packages, as below:

Max number of packages P_{Max}= (R_{BHEL}-60) divided by corresponding value of 'L' i.e. (R_{BHEL}-60)/L

Note:

i. In case the value of P_{Max} results in a fraction, the value of P_{Max} is to be rounded off to next whole number

ii. For R_{BHEL} = 60 , P_{Max} = '1'

iii. For R_{BHEL} ≥ 80, there will be no upper limit on P_{Max}

The Bidder shall be considered 'Qualified' as per 'Assessment of Capacity of Bidder' for the subject Tender if $P \le P_{Max}$

(where P is calculated as per clause 9.1)

IV. **Explanatory note:**

- a) Similar package means Boiler or ESP or Piping or Turbine or Civil or Structure or Electrical or CI, etc at the individual level irrespective of rating of Plant, and irrespective of whether the subject tender is a single package or as part of combined/composite packages. Normally Boiler, ESP, Piping, Turbine, Electrical, CI, Civil, Structure, etc is considered individual level of package. For example in case the tendered scope is a Boiler Vertical Package comprising of Boiler, ESP and Power Cycle Piping (i.e the 'identified packages as per Table 1 below), the 'PERFORMANCE' part against sl no II above, needs to be evaluated considering all the identified packages (ie Boiler, ESP and Power Cycle Piping) and finally the Bidder's capacity to execute the tendered scope is assessed in line with III above

c) Bidders who have not been evaluated for at least six package months in the last 36 months in the online BHEL system for contractor performance evaluation in BHEL PS Regions, wef July'2010 shall be considered "NEW VENDOR".

A 'NEW VENDOR' shall be considered qualified subject to satisfying all other tender conditions

A 'NEW VENDOR' if awarded a job (of package/packages identified under this clause) shall be tagged as "FIRST TIMER" on the date of first LOI from BHEL.

The "FIRST TIMER" tag shall remain till execution of work for a period of not less than 09 months, from the commencement of work of first package

A Bidder shall not be eligible for the next job as long as the Bidder is tagged as "FIRST TIMER" excepting for the Tenders which have been opened on or before the date of the bidder being tagged as 'FIRST TIMER'.

After removal of 'FIRST TIMER' tag, the Bidder shall be considered 'QUALIFIED' for the future tenders subject to satisfying all other tender conditions including 'Capacity Evaluation of Bidders'.

- d) In the unlikely event of all bidders shortlisted against Technical and Financial Qualification criteria not meeting the criteria on 'Assessment of Capacity of Bidders' detailed above, OR leads to a single tender response on applying the criteria of 'Assessment of Capacity of Bidders' or due to non-approval by Customer, then BHEL at its discretion reserves the right to consider the further processing of the Tender based on the Overall Performance Rating 'R_{BHEL}' only, starting from the upper band.
- e) 'Under execution' shall mean works in progress as per the following:
 - i. up to Boiler Steam Blowing in case of Steam Generator and Auxiliaries
 - ii. upto Synchronisation in case of all other works excepting sl no (i) and (iii)
 - iii. Upto execution of at least 90% of anticipated contract value in case of Civil & Structures (unit wise), Enabling works and upto 90% of material unloading (in tonnage) as per the original contract in case of MM Package.
- Note: BHEL at its discretion can extend (or reduce in exceptional cases in line with Contract conditions) the period defined against (i), (ii) and (iii) above, depending upon the balance scope of work to be completed.
- f) Performance evaluation in CL 9 above is applicable to Prime bidder and consortium partner (or Technical tie up partner) for their respective scope of work.
- 10.0 Since the job shall be executed at site, bidders must visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation, applicable wage structure, wage rules, etc before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions.

- For any clarification on the tender document, the bidder may seek the same in writing or through e-mail, as per specified format, within the scheduled date for seeking clarification, from the office of the undersigned. BHEL shall not be responsible for receipt of queries after due date of seeking clarification due to postal delay or any other delays. Any clarification / query received after last date for seeking clarification may not be normally entertained by BHEL and no time extension will be given.
- 12.0 BHEL may decide holding of pre-bid discussion [PBD] with all intending bidders as per date indicated in the NIT. The bidder shall ensure participation for the same at the appointed time, date and place as may be decided by BHEL. Bidders shall plan their visit accordingly. TECHNO-COMMERCIAL SPECIFICATION (TERMS & CONDITIONS)

1. **GENERAL**:

BHEL-PSNR has requirement of Registered AC Taxis of **three different segments (Tata Indigo/ Swift Dzire/ Innova)** for Sr. Executives, Guests and employees including occasional requirement of taxis for local & outstation journeys on **DAILY** rate contract basis. BHEL-PSNR, therefore, intends to empanel reputed Taxi Operator/ Contractor on daily rate contract basis for a period of two years from the date of LOI.

2. SCOPE OF WORK:

- The Contractor shall provide Registered AC Taxis of **three different segments** (**Tata Indigo/ Swift Dzire/ Innova**) of diesel model not more than 18 months old(Date of Registration not before 31 Jan 2012). The cars shall be provided at our office premises at BHEL-PSNR building, Plot No. 25, Sector-16A, Filmcity, Noida or at any other place intimated to the Contractor for travel within or outside Delhi. In case of urgency, BHEL may accept non-commercial taxis.
- 2.2 The contractor shall provide on **DAILY** rate contract basis 'as and when required'.

The anticipated business volume during the contract period of two years towards hiring of taxis shall be as per indent in respect of Hiring of Taxis for BHEL-PSNR Office.

The above figure is indicative for this tender only & does not guarantee the business volume for the contract period of two years. This may increase or decrease depending upon BHEL-PSNR actual requirements.

- 2.3 The contractor shall provide drivers with adequate knowledge of reading, writing and speaking English/Hindi and in proper uniform having knowledge of different routes as well as minor repair of cars and holding valid driving license. The drivers deputed for duty should be polite and must possess positive attitude in discharging their duty. The reporting time, place, address etc. should be strictly followed by Contractor.
- The vehicles provided by the contractor must be in excellent condition and must have proper and complete documents such as RC book/ Insurance/ Road Tax Receipt/ Border Tax in original. The vehicles should comply strictly with the provision of pollution control in line with the directions of Supreme Court regarding pollution norms and regulations from time to time and should also comply with statutory regulations issued by State Transport Authorities/ Central Government. BHEL shall in no way be responsible for any liability arising due to non-compliance of statutory requirements/ regulations w.r.t. the vehicle as well as the driver. The

contractor must also provide a mobile phone to the driver of the vehicle sent for duty.

- The contractor shall maintain the log sheet/ duty slip as per Performa enclosed for every trip/ requisition. No advance money will be paid under any circumstances. Also no interest will be paid due to delay in making the payment.

The bills in duplicate along with log sheets/duty slips duly signed by the user of the vehicle or his representative should be sent to BHEL for its payment. It should be ensured that there is no overwriting in the log sheet/duty slip. Log sheet/duty slip without signature of the user at the specified places shall not be accepted for payment.

The maintenance cost, charges of fuel, road tax, insurance, challans, salary of the driver, the overtime of driver etc. are the responsibility of the contractor and will be borne by the contractor. BHEL will, however, reimburse toll taxes, state levies/ taxes for outstation journeys at actual on submission of receipts in original receipt along with the bill.

Parking charges, Toll Tax, Service Tax and DND payments (without service tax), as applicable from time to time shall also be payable at actual against production of original

receipt along with the bill. In case of hiring of commercial vehicles for use in NCR on daily basis, state entry taxes/levies (without service tax) shall also be payable at actual against production of original receipt along with the bill.

3.8 INSURANCE:

The vehicle provided must be fully and comprehensively insured (latest copy of insurance cover to be enclosed).

3.9 TAXES & DUTIES:

The contractor shall pay all (save the specific exclusions as enumerated in this contract) taxes, fees, license charges, deposits, duties, tools, royalty, commissions or other charges which may be levied on the input goods & services consumed and output goods & services delivered in course of his operations in executing the contract. In case BHEL is forced to pay any of such taxes, BHEL shall have the right to recover the same from his bills or otherwise as deemed fit.

However, provisions regarding Service Tax on output services shall be as per following clauses:

3.9.1 Service Tax & Cess on Service Tax:-

Service Tax and Cess on Service Tax as applicable on output Services are excluded from contractor's scope; therefore contractor's price/rates shall be exclusive of Service Tax and Cess on Output Services. Contractor shall obtain prior written consent of BHEL before billing the amount towards such taxes.

Contractor shall submit to BHEL documentary evidence of Service Tax registration certificate specifying name of services covered under this contract

For the purpose of claiming any Service Tax from BHEL, the following procedure shall be adopted:

Contractor shall submit serially numbered Service Tax and Cess Invoices, signed by him or a person authorized by him in respect of taxable service provided, and shall contain the following, namely:

- 1. The name, address and registration number of the contractor
- 2. The name and address of the party receiving taxable service (BHEL)
- 3. Description, classification and value of taxable service provided and
- 4. The Service Tax payable thereon.

All the four conditions shall be fulfilled in the invoice for payment of Service Tax by BHEL. Where more than one nature of Service under Service Tax Rules is involved, the invoice mentioned above shall contain the break up of all values for each nature of Service

An abatement of 60% in taxable service of Renting of any motor vehicle is available on the condition that the contractor has not availed CENVAT credit on inputs and capital goods and input services, used for providing the taxable service, has not been taken under the provisions of the CEVAT Credit Rules,2004. The Contractor shall provide a declaration issued, to the effect that he has not availed CENVAT credit on inputs and capital goods and input services, used for providing the taxable service, under the provisions of the CEVAT Credit Rules, 2004.

3.9.2 Tax Deduction at Source:-

Tax shall be deducted at source from the running bill as per applicable Income Tax Rules and other statutory requirements.

3.9.3 New Taxes/Levies:

In case the Government imposes any new levy/tax on the output service/goods/work after award of the contract, the same shall be reimbursed by BHEL at actual.

In case any new tax/levy/duty etc. becomes applicable after the date of Bidder's offer, the Bidder/Contractor must convey its impact on his price duly substantiated by documentary evidence in support of the same before opening of Price Bid. Claim for any such impact after opening the Price Bid will not be considered by BHEL for reimbursement of tax or reassessment of offer.

No reimbursement/recovery on account of increase/reduction in the rate of taxes, levies, duties etc. on input goods/services/work shall be made. Such impact shall be taken care of by the Price Variation/Adjustment Clause (PVC) if any.

3.10 **DEVIATION**:

The contractor must comply with the tender specification and all terms and conditions of contract. No deviation shall normally be entertained. BHEL reserves the right to reject any or all quotations without assigning any reason whatsoever.

3.11 PAYMENT TO DRIVER:

Contractor shall be solely responsible for payment of wages/ salaries and allowances to his personnel that might become applicable under any act or order of Govt. from time to time during the validity of contract. BHEL shall have no liability whatsoever on this account (i.e. Statutory compliance with regard to vehicle and also the driver deployed including the wages, allowances, insurance and extra hours charges etc. of the driver deployed).

4. PAYMENTS FOR LOCAL JOURNEYS:

The payment for local journeys will be regulated on the following basis:

- a) For journeys up to 40 KMs & 4 hrs: The payment will be regulated on the itemized rates finalized in the Price Bid.
- b) For journeys beyond 40 KMs and up to 80 KMs or beyond 4 hrs and up to 8 hrs: The payment for the journeys beyond 40 KMs and up to 80 KMs or beyond 4 hrs and up to 8 hrs, will be regulated on the itemized rates finalized for 40 KMs & 4 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made.
- c) For journeys beyond 80 KMs & 8 hrs: For the journeys beyond 80 KMs & 8 hrs., the payment will be regulated on the itemized rates finalized for 80 KMs & 8 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made.

5. PAYMENT FOR OUTSTATION JOURNEYS:

For outstation journeys payment will be restricted to actual KM travelled or 200 KMs per day whichever is higher. Per KM rate & night halt charges finalized in the Price Bid will also be applicable for payment of outstation journeys.

Night halt charges will be made for daily as well as outstation journeys only. NCR (Noida, Gurgaon, Delhi, Faridabad, Ghaziabad, Bawana, Jhajjar and other adjoining towns) will not be considered as "outstations".

6. EVALUATION CRITERIA:

- a) BHEL's "Schedule of Hiring Rates" for different model cars is enclosed (Reference Annexure-I).
- b) Bidders shall quote the rates as per Price Bid Performa (Annexure-I).
- c) The bidders are required to fill % Above OR below OR same in the box provided in the Format. Bidders may please note that they have to fill only one % figure, i.e. either for % Above OR below OR Zero which will be applicable for all model cars required in DAILY basis.
- d) Technical Bids submitted by the tenderer will be opened first and evaluated for fulfilling the Pre-Qualification Criteria and other conditions in NIT/ Tender documents, based on documentary evidences submitted along with the offer.
- e) Price Bids of shortlisted bidders shall only be opened either through the conventional price bid opening or through electronic Reverse auction, at the discretion of BHEL.
- f) Price Bids of unqualified bidders shall not be opened. Reasons for rejection shall be intimated in due course after issue of LOI/LOA to successful bidder and receipt of unconditional acceptance from the successful bidder.

7. PENALTY:

Penalty @ Rs. 500/- shall be enforced in the event of refusal by the contractor to provide the required vehicle on third refusal and on every subsequent refusal in a month.

8. ARBITRATION:

In the event of any dispute or difference whatsoever arising under this contract or in connection therewith including any dispute relating to existing meaning and interpretation of this contract, the same shall be referred for arbitration by BHEL. The arbitration shall be conducted in accordance with the provisions of the Arbitration & Conciliation Act 1996.
