1. Offers are invited from experienced manufacturers of Inorganic **Ethyl Zinc silicate primer** meeting the Pre-Qualification Requirement (PQR) against this tender enquiry.
 2. Offers received from bidders meeting the Pre-Qualification Requirements shall only be considered and other offers will be summarily rejected.
 3. Bidder should submit/Upload the supporting documents called for in the PQR (Annexure –P), Annexure-M, Annexure-N (If applicable) along with technical bid. Incomplete bids are liable to be rejected.
 4. The **Ethyl Zinc silicate primer** shall be as per specification.
 5. ~~SPECIFICATION DEVIATION DISPOSITION REPORT (Annexure -C) shall be submitted along with technical bid.~~
 6. ~~Manufacturer Quality plan to be submitted for BHEL approval along with Technical Bid.~~
 7. **Offer from Bidders with pending supplies to BHEL- Ranipet, overdue for more than two months (ie., two months or beyond the stipulated delivery of BHEL-Ranipet purchase order), as on date of technical bid opening are liable to be rejected.**
 8. **Evaluation of Offer: Refer Annexure –R (Annual Rate Contract Terms and Conditions) for the price evaluation methodology.**
 9. **All the pages of tender documents shall be signed with seal by authorized person and to be uploaded/submitted on e-procurement site along with technical bid as an evidence of having read the same and acceptance of the terms and conditions. Offer received without this are liable for rejection**
 10. ~~BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking.~~

- 6) BHEL reserves the right to split the tendered quantity against each enquiry in the ratio of 70:30 among the L1 and L2 vendors respectively. The L1 rate will be counter offered to the L2 vendor and upon acceptance of the counter offer, PO will be placed on L2 vendor for 30% of the enquiry quantity. If L2 vendor does not accept counter offer, it will be counter offered to next higher bidders.
