21."BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders.

Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."

Note - Vendors to note that above RA clause will supersede clause no 13 of "Instruction to Bidders "of GCC Rev 07

22. Tender Evaluation - Evaluation will be done on overall L1 (Total Cost to BHEL excluding GST) basis for complete scope of the tender with necessary loading as applicable.

For the case of RA, the loading (technical/commercial), if any, shall be added by bidder while submitting the bid in reverse auction portal.

Ordering shall be done after de-loading the commercial/ technical loading from bidder's final price.

In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L-1 bidder (s) or their representative(s). Ranking will be done accordingly. BHEL's decision in such situations shall be final & binding.

- 23. Terms & Conditions:- The terms & conditions shall be as per enclosed special conditions of the contract (copy enclosed), GCC Rev 07 which is available on www.bhelpem.com and other Terms and Conditions included in this Enquiry Letter.
- 24. BGs should be in favour of BHEL-PSSR in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-07.
- 25. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.
- 26.Bidder to note that this is an Open Tender enquiry & Price bid (Part-II) opening/RA participation shall be subject to following condition:
 - a) Qualifying Technical & Financial Pre-Qualification Requirement.
 - b) Techno-commercial acceptance of offer by BHEL-PEM.
 - c) Approval of bidder by End Customer: Same shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credential as per the format enclosed herewith along with their technical bid.

The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. - 27.Regarding verification of PQR Documents:-Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organisation contact number and email Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.
- 28. All corrigenda, addenda, amendments, time extensions, clarifications, etc. to the tender will be hosted on BHEL website (www.bhel.com), https://bhel.abcprocure.com & BHEL-PEM website (www.bhelpem.com). Bidders should regularly visit websites to keep themselves updated.

- 31.In case of joint bidding, bidders to furnish scope matrix which should be clearly defined between them along with the offer for the complete scope.
- 32. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.
- 33. This item/package/system falls under the list of items defined in para 03 of Ministry of Finance guidelines dated 20.09.2016 (procurement of items related to public safety, health, critical security operations and equipments, etc.) & hence criteria of prior experience/turnover shall be same for all the bidders including start-up/MSME.

34. <u>Deductibles/ Excess: Following Deductibles/ EXCESS may be considered.</u>

Insurance Policy of this project is not available. However, Deductibles / EXCESS shall be as per available last CPIM policy and changes, if any in deductible / excess, w.r.t actual insurance policy for 5x800 MW Yadadri project shall be informed to the bidders before P-1 opening.

For Marine Cover: 0.25% of consignment value subject to minimum of Rs 20,000/-

- B) For Storage /Erection and Testing Cover:

- 37. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.
- 38. In line with cl. No. 26 (Make in India) of GCC rev 07 (ITB), LATEST GUIDELINES/ MAKE IN INDIA ORDER received shall be followed
- 39. All Bidders will be asked to comply government of India order dated 02.07.2020 regarding mandatory tes ting of all the imported items/equipments/components.
- 40..Bidders may visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation etc. before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions. No additional claim shall be entertained by BHEL in future, on account of non-acquaintance of above.
- 41.All the above terms and conditions, post-bid agreements/MoMs (during Techno- Commercial evaluation) shall automatically become a part of the Order/Contract after its finalisation.
- 42.Bidders to note that offers shall be submitted strictly in accordance with the requirements of tender documents. Bidders shall upload their complete offer meeting the requirements of the tender documents on e-procurement portal https://bhel.abcprocure.com.
