- **1.1 Price:** Price should be quoted strictly as per performa for price bid. FOR destination basis inclusive of transportation, or any other transport expenditure. Vendor has to supply the item / Equipment at the delivery place as mentioned in clause 1.8
- 1.2 Documents Required: Vendor has to submit the following documents:
  - a) QAP Copy duly stamped and signed
  - b) Acceptance of technical terms & Annexure I,II,III & (IV Price bid in separate sealed envelope)
- 1.3 Validity of Offer: Six months from the date of technical bid opening / extended date.
- **1.4 Price variation:** Price offered should remain firm till the completion and handing over of elevators.
- **1.5 Delivery Period:** Within five (5) months form the date of issue manufacturing clearance / drawing, QAP, datasheet approval whichever is later, early delivery will be preferred. (Drawing / QAP to be submitted within 4 weeks, approval time 4 weeks and 3 months for manufacturing after drawing / QAP approval against each elevator.
- 1.6 Delayed Delivery Penalty: LD shall be 0.5% per week of the unfurnished portion of the order value or part thereof subject to a maximum of 10% of the full order value (supply portion). In case of any change to the order value the LD od 0.5% of the revised unfurnished portion of the order value per of delay or part thereof subject to a maximum of 10% of the revised value. - **1.9 Transportation:** To be arranged by vendor. Transportation charges may be quoted separately in price bid as per clause 1.8.

1.11 Payment Terms:

- Payment of 80 % basic cost towards design, material supply + mandatory spares, tools & instruments + 100% taxes, duties, transportation will be made within 90 days on submission of bills along with proof of receipt and acceptance of material at site (45 days for MSE vendors MSE vendor may kindly furnish Annexure A enclosed duly signed stamped and certified by their CA)
- Payment of 10% of the basic order value will be made within 90 days against erection, commissioning and handing over the elevator.
- Balance 10% of the basic value will be made within 90 days against submission of PBG (Performance Bank Guarantee) valid for 24 months from the date of handing over the elevator.
- In case of any deviation to the payment terms mentioned above, <u>loading shall be done</u> on basic price with the PLR (Prime Lending Rate) of SBI + 6 % for the period of relaxation sought by the bidder (PLR shall be considered from the date of technical bid opening)
- Payment will be made through e-payment only. Vendors should furnish full bank details.
- NO ADVANCE PAYMENT WILL BE MADE.
- 1.12 Taxes & Duties: Bidder to clearly specify the taxes and duties applicable on the date of submission of the offer. However, any statutory variation in the rate of taxes and duties after the date of submission shall be considered and actual rates applicable at the time of dispatch of material shall be payable at actual against documentary evidence.
- 1.12.1 Excise Duty: Extra as applicable.
- 1.12.2 MODVAT Credit: If any Excise duty is payable, the chapter head / sub-head reference and the rate of duty should be quoted. If the bidder is not availing MODVAT credit for these input material, the effect of proforma should be passed to the purchaser.
- **1.12.3 Sales Tax:** Extra at actual against Form 'C' shall be paid wherever applicable. This being a 6(2) sale, vendor will have to submit E1/E form.
- **1.13 Insurance:** By vendor till erection, commissioning and handing over the elevator to the customer.
- 1.14 Octroi / Entry Charges (if applicable): Toll Tax, entry tax, octroi etc., (if applicable) shall be in vendor scope, Road permit (if applicable / required).
- 1.15 Inspection: BHEL /or its customer /TPI shall inspect the material before dispatch. In the event BHEL / customer waives off inspection, certified test report and results shall be submitted for approval. Vendor has to submit QAP along with all relevant test certificates / calibration certificates and obtain approval on the test reports and material dispatch clearance certificate MDCC before dispatch of material.
- 1.16 Interpretation of contract: In case of two or more than two interpretations or differences in any of the technical specification or terms and conditions of the contract then the interpretation which is in favour of BHEL shall be final and binding.
- 1.17 Evaluation Criteria: Price evaluation shall be done on the basis of total landed cost of the elevator with erection, commissioning and inclusive of all spares cost to BHEL.

- **1.18 Applicable Standard:** Items quoted shall be of reputed make meeting EC or equivalent international standards.
- **1.19 Dispatch Documents:** dispatch documents shall normally consist of copy of LR, invoice cum excise duty gate pass, delivery challan, test certificates / reports, packing list and guarantee / warrantee certificates.
- **1.20** Guarantee Certificate: Vendor to furnish guarantee certificate for a period of 24 months as per specification each complete with all auxiliaries, spares parts warranting a trouble free operation.
- **1.21 Warrantee Certificate:** Vendor to furnish warrantee certificate for a period of 24 months from the date of delivery or 18 months from the date of commissioning whichever is later.
- **1.22 Submission of QAP:** vendor to submit QA plan as per schedule of the material for further dispatch. Copy of QAP is enclosed.
- 1.23 Risk Purchase: in case successful tenderer fails to adhere to the agreed schedule for supply or fails to comply with the terms and conditions of the purchase order. BHEL reserves the right to source such material /component/ equipment/system from any other agency at the risk and cost of the successful tenderer. The cost of such purchase along with 25% over head charges shall be recovered from the bills pending from any other unit of BHEL. In event of no amount being out standing from BHEL, successful tenderer shall be liable to pay to BHEL the above amount immediately on demand. The decision regarding applying risk and purchase clause from BHEL shall be final and binding.
- 1.24 Force Majeure: The supplier shall not be considered in default, if delay occurs due to causes beyond their control such as act of God, natural calamities, frost, fire, flood, civil war, civil commotion, riots, and government restrictions. Only those clause that have duration of more than seven days shall be considered cause of force majeure. Notification to this affect duly certifies by local chamber of commerce / statutory authorities with supporting documents shall be given by the supplier to BHEL by registered letter / courier services without loss of time. In the event of delay due to such causes the delivery schedule shall be extended for a length of time equal to the period of force majeure or at the option of BHEL the order may be cancelled. Such cancellation would be without any liability what so ever on the part of BHEL. In the event of such cancellation the supplier shall refund any amount advanced or paid to the supplier by BHEL and release facilities, if any provided by BHEL.
- **1.25** Purchase: Preference will be given to CPSU as per government guidelines.
- **1.26** Container: Material to be supplied in container & will be in the custody of the vendor till erection, commissioning and handing over of the elevator. (Free container charges for six months)
- 1.27 Customer Approval: (For Vendor / Make other than customer approved as mentioned in NIT.) Such vendors meeting our commercial & PQC will be considered only after obtaining customer approval for their make.
- 1.28 General Terms & Conditions (3.1 to 3.5): Vendor to accept all general terms & conditions

### 2. PROCEDURE FOR SUBMISSION OF TENDER

- 2.3 Part 'B' Price-Bid
- 2.4 Tender no. date and due date of opening should be written on both the covers. These two covers shall then be placed in a large cover and sealed. The large cover should also have tender no. Date and Due Date. Tis should be dropped in the tender box placed at the entrance of our works before the due date and time.
- 2.5 Part –'A': Techno-Commercial Bid: Techno-commercial bid shall contain technical and commercial offer as per the NIT proforma, indicating acceptance of NIT terms as per Annexure I Acceptance of all technical and commercial terms and conditions given in format Annexure I. (No-Deviation certificate and deviation proforma), duly filled in signed as required. Blank price bid proforma indicating only the rates of taxes and duties applicable, without rate / price for the material should be enclosed with the techno commercial bid Part 'A'
- 2.6 Any deviation in the above mentioned terms & conditions or conditional offer may render the offer invalid and shall be liable to be rejected, and price bids of such bidders shall not be opened.
