- **6.** Packing requirement: The supplier shall arrange for securely protecting and packing the electrodes to avoid loss or damage during transit. - 7. Labelling: The following marking should be made in each package: BHEL

  The above mark should be stenciled on the package itself. If the packages are too small, suitable cards giving these details may be tagged under seal of the seller. Special precautions shall be taken to prevent rusting and corrosion on metal part during transit.
- **8. Rejection and replacement:** Supplier shall arrange replacement within 15 days from the date of rejection of any lot of items and the mode of dispatch at their own cost.
