1. Pre-Qualifying Requirements:

2. Bidders have to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by Customer (NLC), shall be subjected to approval of bidder by the customer.

3. Bidders have to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract and as per these Notice Inviting Tender (NIT) conditions. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit online sealed bid in the Reverse Auction. Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
