4. Rate is to be quoted in the above work/ rate schedule. Rate is to be quoted per day.
5. Number of vehicle(s) can be increased as per requirement of BHEL.
6. BHEL does not guarantee any minimum usage i.e. no. of days
7. The quoted rates should be inclusive of cost of diesel/ petrol/ lubricants, etc. and salary of the crew; repair and maintenance expenditure etc., of the vehicle and inclusive of spare parts and tools, etc.
8. **CLARIFICATION REGARDING GST:** In case any changes in taxes and duties as per Govt. Notification (including GST), the same shall be applicable from time to time.
9. Bid should be free from correction, overwriting, using corrective fluid, etc. Any interlineation, cutting, erasure, or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid, else bid shall be liable for rejection.
