Clause 1.0:

The tenders shall be submitted in two parts (**Part I** consisting of Techno-Commercial Bid, quality plan, replica of price bid & pre-qualification requirements and **Part II** Original Price Bid) as described below on or before the due date.

BHEL will deal directly with the manufacturer and no correspondence with the agents will be entertained. The agents will not be permitted to visit / interact with BHEL on behalf of their principals. Vendor should have experience of manufacturing, testing and supply of Oil Throttle valve, along with its flushing operation, to atleast two units of power-plants^{\$} in a period of 7 years (seven years) prior to issuance of enquiry (i.e. PO shall be within 7 years before date of issuance of enquiry). Description of Oil Throttle Valve:-

Oil throttle valves are installed in lube oil supply line to turbine-generator bearings for regulating the flow of oil to each bearing of Steam Turbine & Generators. Type of Valve: Globe Type. The plug of Oil Throttle valve is cylindrical is shape with openings cut into it across the length. The regulation of oil flow is achieved by rotating its stem. The stem has threads (counter-threads are in valve cover). When the stem is rotated, it moves up and down. Due to this up and down movement of stem and hence plug, the flow area available to fluid changes which allows for flow regulation. Characteristic curves of the Valves are also to be supplied at different differentialpressures (ΔP) wherein valve opening (also known as piston travel) is shown in X-axis and flow is shown in Y-axis. Characteristic curves are required for ΔP varying between 0.25bar to 3 bar. These curves are obtained by actual testing of the valve prototype. Material of valve is Stainless Steel.

For the purpose of this enquiry the above mentioned valve type and description is meant/defined and is to be understood/supplied by vendor. Other types of Oil Throttles like butterfly valves, disc valves, needle valves etc are not meant and not to be understood. Refer Figure 1 for Oil Throttle Valve.

The "flushing operation" is also supplied along with the valve for declaration of flushing in each individual line going to Turbine and Generator bearings. These are components which are used in flushing of the lube oil. Parts of flushing operation include flushing strainer, pin extractor, gaskets, flange, etc. Refer Figure 2 for Flushing Operation.

Some of the technical details of the valves required by BHEL are mentioned below:-

- Range of flow, range of travel and range of differential pressure are mentioned in Table-1. Each throttle valve of a particular size shall work for the full range of differential pressure, flow & travel indicated in Table-1 against it. Eg. Nb50 valve shall work for range of oil flow from 0-80 m3/hr with range of travel from 0 -45 mm at different differential pressures ranging from 0.25-3.0 bar
- 2. Throttle valve as shown in Figure-1 must be equipped with a minimum flow hole so that even if it is fully closed then also some minimum amount of oil shall go to turbine/generator bearings.
- 3. The flushing operation as indicated in Figure -2 must be of basket type lined mesh stainless steel screen. Mesh size is 185 microns. The screen of strainer should be sandwiched between two perforated sheets.

In case the vendor meets the acceptance criterion mentioned in PQR document, other technical details of these valves shall be furnished to them after signing of Non-Disclosure Agreement (NDA) between vendor and BHEL.





FIGURE-1: OIL THROTTLE VALVE

11. BANK GUARANTEE.

In case the bank guarantees are required to be deposited towards security deposit / performance guarantee or for any other purpose as per the terms of this tender enquiry, such bank guarantees of the requisite value in the denominated currency of the purchase order should be from one of the Indian branch of BHEL consortium banks and the bank guarantee should be in the proforma as prescribed by BHEL. 13. QUALITY REQUIREMENT.

Failure on the part of seller to inform dispatch particulars will make him liable to pay for any transit damages / losses suffered by the Purchaser.

17. PHYTOSANITARY CERTIFICATE:

 a) As per the Indian Law, all consignments being imported into India by air / sea require a phytosanitary certificate from the country of origin-if articles have been packed with wooden packaging materials. 19. FORCE MAJEURE CLAUSE.

Notwithstanding any other thing contained anywhere else in the contract or PO (Purchase Order), In case the discharge of obligation under the contract by either party is impeded or made unreasonably onerous, neither party shall be considered in breach of the contract to the extent that performance of their respective obligation is prevented by an event of Force Majeure that arises after the effective date (PO date).

In the above clause, Force Majeure means an event beyond the control of the parties to the contract which prevents a party from complying with any obligation of the contract including but not limited to:

- a) Act of God (Such as but not limited to earthquake, drought, tidal waves, floods etc.).
- b) War (whether war be declared or not), Hostilities Invasion, Act of foreign enemy etc.
- c) Rebellion, revolution, insurrection, civil war etc.
- Contamination of Radio Activity from any nuclear fuel or from any other nuclear waste or any other hazardous materials.
- e) Riots, commotions, strike unless restricted to the employees of supplier.
- f) Acts of terrorism.
- g) Other unforeseeable circumstances beyond the control of the parties and which the affected party cannot avoid even by using its best efforts.
- h) Cancellation of contract by customer.
- i) Change in law/ government. Regulation making the performance impossible.

The party claiming to be affected by force majeure shall notify the other party in writing immediately without delay on the intervention and on the cessation of such circumstances.

As soon as reasonably practicable following the date of commencement of a Force Majeure Event, and within a reasonable time following the date of termination of a Force Majeure Event, either Party invoking it shall submit to the other Party reasonable proof of the nature of the Force Majeure Event and of its effect upon the performance of the Party's obligations under this Agreement.

The party shall, and shall ensure that its Subcontractors shall, at all times take all reasonable steps within their respective powers and consistent with Good Operating Practices (but without incurring unreasonable additional costs) to:

- a) Prevent Force Majeure Events affecting the performance of the party's obligations under this Agreement;
- **b)** mitigate the effect of any Force Majeure Event; and
- c) Comply with its obligations under this Agreement.

If the war like situation has developed in a country where a seller's works is located in the P.O. or there is political instability and Indian Embassy located in that country forbids or advises for not having any business dealing with the sellers located in such zone / region/ country, then BHEL reserves the right to cancel the order.

20. NON-DISCLOSURE AGREEMENT.

All Drawing and Technical Documents relating to the product or it's manufacture submitted by one party to the other, prior or subsequent to the formation of contract, shall remain property of the submitting party. Drawing, technical documents or other technical information received by one party, shall not without the consent of the other party, be used for any other purpose than that, for which they were provided. Patterns supplied by BHEL will remain BHEL's property which shall be returned by the bidder on demand to BHEL. Bidder shall in no way share or use such intellectual property of BHEL to promote his own business with others. 21. SETTLEMENT OF DISPUTES/ARBITRATION.

Any dispute/difference arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration under the Arbitration and Conciliation Act, 1996 of India by a Sole Arbitrator to be appointed with mutual consent of the parties. Such Sole Arbitrator shall be either a retired judge of Supreme Court or High Court or District Court of India or some Advocate having practiced in Indian Courts. The seat or place of arbitration shall be New Delhi, India. The language to be used in the arbitration shall be English. The governing law of the contract shall be the substantive law of India. In case the parties fail to agree on the appointment of arbitrator within 2 months of the notice invoking arbitration by one party, then the

11. TAXES & DUTIES.

- a) The bidder to specify in their offer (part 1 bid) the category of their registration under GST like Registered, Unregistered and composite dealer.
- b) The provisional GST registration number of Bharat Heavy Electrical Ltd, Heavy Electricals Equipment Plant, Ranipur, Haridwar is <u>"05AAACB4146P1ZL"</u> with state Code as "05" and State Name as "Uttarakhand".

The party shall, and shall ensure that its Subcontractors shall, at all times take all reasonable steps within their respective powers and consistent with Good Operating Practices (but without incurring unreasonable additional costs) to:

- a) Prevent Force Majeure Events affecting the performance of the party's obligations under this Agreement.
- **b)** mitigate the effect of any Force Majeure Event and
- c) Comply with its obligations under this Agreement.

If the war like situation has developed in a country where a seller's works is located in this P.O. or there is political instability and Indian Embassy located in that country forbids or advises for not having any business dealing with the sellers located in such zone / region/ country, then BHEL reserves the right to cancel the order.

20. NON-DISCLOSURE AGREEMENT.

All Drawing and Technical Documents relating to the product or it's manufacture submitted by one party to the other, prior or subsequent to the formation of contract, shall remain property of the submitting party. Drawing, technical documents or other technical information received by one party, shall not without the consent of the other party, be used for any other purpose than that, for which they were provided. Such technical information shall not without the consent of the submitting party, otherwise be used or copied, reproduced, transmitted or communicated to a third party. Patterns supplied by BHEL will remain BHEL's property which shall be returned by the bidder on demand to BHEL. Bidder shall in no way share or use such intellectual property of BHEL to promote his own business with others. BHEL reserves the right to claim damages from the bidder, or take appropriate penal action as deemed fit against the bidder, for any infringement of the provisions contained herein.

21.<u>SETTLEMENT OF DISPUTES / ARBITRATION</u>.

Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two-part bid) or vendor has to give Udyog Adhar Memorandum (UAM). Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents is found or the requisite documents are not submitted before price bid opening.
