# I. <u>ELIGIBILITY CRITERIA</u>

- 1. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head.
- 2. The Bidder should have valid Income Tax **PAN Card**. Documentary proofs / Xerox copies are to be enclosed.
- 3. The agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business documentary proof / Xerox copy to be enclosed.
- 4. The bidder shall be in the Shot blasting field in industries for a period of minimum One Year. Supporting documents copy has to be enclosed with the offer.
- 5. The blaster identified for deputation to BHEL for the above work shall have an experience of minimum 3 months in shot blasting operations. The detailed experience certificate for identified blaster shall be submitted along with the offer.
- 6. On award of contract, the successful bidder shall comply with all the statutory requirements of PF rules & regulations for their workmen deputed for this work. An undertaking of acceptance (**refer point No.06 of Technical bid**) has to be given.
- 7. On award of contract, the successful bidder shall comply with all the statutory requirements of ESI/GI rules & regulations for their workmen deputed for this work. An undertaking of acceptance (refer point No.07 of Technical bid) has to be given.
- 8. Only those bidders, who are meeting all the above qualifying criteria, will be considered for further evaluation and others will be summarily rejected.
- 9. The eligibility Criteria details as per **Annexure X** to be filled & submitted with supporting documents for BHEL reference and verification.

#### II. SCOPE OF CONTRACT:

#### A. Name of Work:

- 1. To carry out Shot Blasting Operation at BHEL-PPPU-Thirumayam premises.
- Contractor shall provide services for Shot Blasting operation of steel pipes as and when required at Power Plant Piping Unit - Thirumayam - 622 507 assigned by concerned official in-charge.

#### B. Quantum of Work :

- 1. Total Surface area to be blasted by contractor is approx. 1780 Sq. m or 6 Months from the date of commencement of work, whichever is earlier. The work shall be attended as and when called by BHEL/PPPU during the contract period.
- 2. Contractor shall engage his Labours of minimum crew strength of one blaster and one helper for the work as and when informed by BHEL (with in contract period)

- 3. The blasting crew (1 blaster and 1 helper) should be reported to BHEL works within 24 hours of BHEL's call.

## C. TECHNICAL SPECIFICATION: (SCOPE OF WORK)

- 1. The contractor shall provide services for shot blasting operation of steel pipes at Power Plant Piping Unit, Thirumayam assigned by concerned official in-charge, by engaging his own Labours of minimum crew strength of one blaster and one helper as and when required by BHEL.
- 2. Shot, Shot blasting equipment, power, compressed air will be provided by BHEL at free of cost.
- 3. The basic maintenance of the shot blasting equipment and the accessories (including filter cleaning) is under the scope of the contractor.
- 4. Jobs will be moved in and out of the blasting facility room by BHEL, free of cost.
- 5. Contractor shall blast the job, meeting the requirement and obtain the clearance from QC / BHEL.
- 6. The contractor shall collect and reuse the shots provided to them. The segregation of shots from the mix of scales, dusts, shots etc. (after blasting) is under the scope of the contractor for which suitable mesh have to be brought by the contractor.
- 7. Personal Protective Equipment's (PPE) / Safety Gadgets as per Industry standards and needs for the blaster / helpers are under the scope of the contractor.
- 8. Adequate care shall be exercised while carrying out blasting cleaning of P91 Spec pipes so that all the scales formed during heat treatment shall be removed.
- 9. Regular housekeeping and cleaning of the entire area inside and also near the shot blasting section is under the scope of the contractor.
- 10. Disposal of dusts / scales / unusual shots etc. from the shot blasting area to be specified places within the BHEL factory area is under the scope of the contractor.
- 11. The contractor shall mobilize workforce to BHEL premises at his own cost and risk.

## D. BHEL'S responsibility:

BHEL, Thirumayam will provide the following free of cost to the contractor for carrying out the job as detailed under scope of work:

- 1. Space for working
- 2. Compressed air
- 3. Electric power
- 4. Movement of jobs to the blasting facility and taking back to respective bays.
- 5. Shots and shot blasting equipments

All other requirements related to above-mentioned work shall be provided by the contractor.

### E. Timing for Work:

The shot blasting crew of minimum one blaster and one helper has to attend the work at BHEL-Thirumayam works as and when called by BHEL, during working hours

Working hours: -

- 1. General Shift i.e., "G" Shift from 07.30 AM to 04.30 PM
- 2. Night Shift i.e., "N" Shift\* from 04.00 PM to 01.00 AM (next day)
- 3. "A" Shift from 06.00 AM to 02.00 PM
- 4. "B" Shift from 02.00 PM to 10.00 PM

\*Depending upon the necessity of the work, occasionally shot blasting to be done in Night shift with advance information to contractor

#### NOTE:

- 1. In case of need, the working time will be extended by TWO hours on the day of duty.
- 2. For work on Sundays and Holidays (except National Holidays), regular shift will be operated with advance notice.
- 3. The working Time accounted against the individual will be certified by BHEL staff based on the actual engagement time & the work Output.
- 4. Payment will be made to vendor based on the shot blasted area done by them and they shall claim the amount, Rate in Rs per Sq. m of area only (in Rupees per Square meter)

## F. General Requirements for Workmen:

- 1. No lady / women worker shall be engaged.
- 2. The age of the individual shall be between 18 yrs. and 45 yrs.
- 3. The individual shall be physically and mentally fit to work in an industrial environment.
- 4. Academically the individual shall have completed minimum education in 8<sup>th</sup> Standard level.

#### G. Deployment of Workforce:

- 1. The quantum of work per day will vary from time to time depending on the shop-floor loading. If likely condition of break in service requirement and change in operating shifts occurred, advance information will be given to contractor by BHEL.
- 2. Contractor shall be responsible to complete the assigned work within the time frame indicated.
- 3. Shift wise attendance register with 'IN' and 'OUT' timing shall be maintained by the contractor and shall be countersigned by the BHEL Staff, at the end of each shift of duty.
- 4. The workmen deployed shall wear uniform (cotton mixed jet black trousers and steel grey plain full sleeve shirts), black industrial safety shoes, yellow colour industrial helmet, safety goggles, hand gloves and identification card during the hours of engagement within BHEL premises.

5. Contractor shall provide all the above specified safety gadgets and uniform materials to his workforce at his cost, and shall be responsible for enforcing all safety regulations as applicable.

#### III. WORK SPECIFIC TERMS & CONDITIONS:

- 1. BHEL will provide food at subsidized rate to the contract workers as per the extant rules and the cost of food supplied will be deducted from the contract bill amount.
- 2. The contractor shall follow and comply with PF, Group Insurance and other statutory regulations as stipulated in Factory's Act and associated State as well as Central Governments' rules and regulations stipulated.
- 3. BHEL is in no way responsible for any loss of life or any injury caused to any of the contractor's work force or equipment while executing the above listed work at BHEL premises.
- 4. The contractor's crew shall handle the machinery and other equipment entrusted to them by BHEL with utmost care and returns them safely after execution of stipulated work. The cost of damage, repair due to improper handling of machinery and equipment will be recovered from the contractor.
- 5. BHEL reserves the right to alter any of the terms & conditions of the contract and any such changes will be intimated to the contractor from time to time.
- 6. BHEL reserves the right to cancel and terminate the contract at any time without assigning any reason.
- 7. The contractor should maintain a 'Work Diary' containing the details of work executed by him from time to time on daily basis and obtain the signature from official concerned nominated for this purpose for having executed the work correctly and satisfactorily.
- 8. The proof of execution of work should be submitted along with each bill. (Printed form with covering letter and proof for execution of work along with attendance particulars)
- 9. Necessary gate entry pass will be issued by BHEL Security Department on User Department recommendation for your crew and Security Rules are to be observed strictly by the contractor and their crew.
- 10. Adherence of Terms & Conditions as per the NIT of the subjected Works Contract.

#### IV. COMMERCIAL TERMS & CONDITIONS:

#### 01. RATE:

(a) The rates quoted should be valid for 90 days initially from the date of opening of the price bid/Reverse Auction Process. The rates of successful bidder should be valid for 6 months from the date of commencement of the contract.

- (b) The rates quoted should be exclusive of service tax and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.
- (c) All entries in the tender documents should be in one ink. Erasures and overwriting are not permitted. All cancellations and insertions should be duly attested by the Bidders concerned.
- (d) Rates should be quoted as per the Price Bid format, enclosed. Rates quoted in any other form will not be accepted and will be rejected.
- (e) Unit rates should be quoted in figures as well as in words for all the items shown in the attached schedule. Wherever there is a difference in the two, **the rates in words will be taken as final**.
- (f) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.
- (g) Contractor has to ensure that all statutory payment as per Minimum Wages Act / Payment of Wages Act etc. and BHEL additional monthly payment (as indicated in Welfare Conditions) to be taken care of while quoting. No claim in respect of payment to workmen will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.
- (h) It is necessary, that the Contractor has to visit BHEL with prior notice and seeks clarification, if any, before offering the most Competitive Rate for the subjected work.

#### 02. PAYMENT TERMS:

The consolidated statements and Bills in triplicate shall be prepared by the Contractor for completed work (Surface Area blasted) during the first week of succeeding month and submitted to concerned **End User** & after due certification from **End User**, the bills will be forwarded to Accounts Section. The payment will be made through RTGS / EFT to the contractor immediately after the receipt of the error free bill. It is to be noted that it will take around ten days to process the bill at **End User** and Accounts section after submission.

#### 03. CONTRACT PERIOD

- (a) The contract execution period will be for a period of **6 Months** from the date of commencement of work or 1780 Sq. m Surface area blasted, whichever is earlier.
- (b) If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
- (c) The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL.

## 04. SECURITY DEPOSIT:

(a) Security Deposit should be paid by the contractor. Security Deposit shall be collected from the successful Bidder as shown below:

Contract Value Up to Rs.10 Lakhs Above Rs.10 Lakhs up to Rs.50 Lakhs Above Rs.50 Lakhs : 10% : 1 Lakh + 7.5% of the amount exceeding Rs.10 Lakhs

: 4 Lakhs + 5% of the amount exceeding Rs.50 Lakhs

The Contractor should remit the Security Deposit before start of the work, if the contract value is more than 10 Lakhs. Otherwise contractor can start the work as per Letter of Intent (LOI) & Security deposit shall be remitted subsequently. The EMD amount shall be converted as security deposit and the balance amount shall be remitted. No interest will be paid to the Contractor for the amount deposited during the period of agreement.

Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and shall result in cancellation of the contract and the Bidder shall be liable to compensate BHEL for any losses incurred by BHEL. EMD in such cases shall be forfeited.

The security deposit shall be refunded within a reasonable time after the date of successful completion of the contract i.e. the Contractor carrying out all obligations / operations as required under the contract agreement.

BHEL reserves the right to appropriate any part or the whole of the amount of the security deposit without prejudice to other claims against this Contractor for losses suffered by BHEL due to failures on the part of the Contractor or due to termination of contract or Contractor becoming disqualified because of liquidation / insolvency or change of composition. The decision of BHEL in respect of such losses, damages, charges, expenses or costs, shall be final and binding on the Contractor and the decision shall not be questionable.

(b) The Security Deposit may be submitted in any one of the following forms:

- Cash (as permissible under the Income Tax Act)
- Pay Order, Demand Draft in favour of BHEL.
- Local cheque of scheduled banks, subject to realization.
- Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc. (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back) and with minimum validity of covering the contract period.
- Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL and with minimum validity of covering the contract period.
- In order to ensure the genuineness of BG's, the BG's are to be sent directly by the concerned bank through registered post to Senior Manager / Contracts, Power Plant Piping Unit (PPPU), BHEL Thirumayam 622 507.
- Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back and with minimum validity of covering the contract period.

• Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be remitted (any of the above form) by the vendor before start of work and the balance 50% may be recovered from the running bills.

#### The security deposit shall not carry any interest.

The Earnest Money paid at the time of tender will be converted as part of the Security **Deposit** and the balance amount will be collected from the contractor as mentioned above.

Security Deposit shall not be refunded except in accordance with the terms and conditions of contract or tender enquiry. No interest shall be allowed on Security Deposits. BHEL shall not be responsible for any loss of securities, due to liquidation for any other reasons, what-so-ever or any depreciation in the value of the securities while in their charge or for any loss of interest there on.

All compensation or other sums of money payable by the Contractor to BHEL under the terms of this contract or under any other contract with BHEL may be deducted from the Security Deposit or realized by the sale of the securities or from the interest arising there from or from any sums which may be due or may become due to the contractor by BHEL and in the event of this Security Deposit being deducted by reason of such deductions or sale, as aforesaid, the Contractor shall within 7 days thereafter, make good in cash or in securities endorsed as aforesaid, any sum by which the Security Deposit has been reduced.

#### **05. TENDER EVALUATION:**

- (a) The Bidder should submit the details as per the Price Bid format only.
- (b) L1 will be decided on minimum of the total sum (A x B) for serial No. 1 of Price Bid on a Single vendor basis for entire quantum of work.
- (c) BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit "online sealed bid" in the Reverse Auction. Non-submission of "online sealed bid" by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue."

#### <u> Annexure – E</u>

#### Terms & Conditions of Reverse Auction

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to "REVERSE AUCTION PROCEDURE" i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

- 1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
- 2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit "online sealed bid" in the Reverse Auction. Non-submission of "online sealed bid" by the bidder for any of the eligible items for which techno-commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
- 3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
- 4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
- 5. Business rules like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
- 6. Bidders have to fax the Compliance form before start of Reverse auction. Without this, the bidder will not be eligible to participate in the event.
- 7. In line with the NIT terms, BHEL will provide the calculation sheet (e.g., EXCEL sheet) which will help to arrive at "Total Cost to BHEL" like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, Service Tax for Services and loading factors (for non-compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
- 8. Reverse auction will be conducted on scheduled date & time.
- 9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.
- 10. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, (Annexure VII) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
- 11. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL's standard practice.
- 12. Bidders shall be required to read the "Terms and Conditions" section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. - 13. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action *as per extant BHEL guidelines*, shall be initiated by BHEL and the results of the RA scrapped/ aborted.
- 14. The Bidder shall not divulge either his Bids or any other exclusive details of BHEL to any other party.
- 15. In case BHEL decides to go for reverse auction, the H1 bidder (whose quote is highest in online sealed bid) may not be allowed to participate in further RA process.

#### V. CONDITIONS RELATED TO THE WELFARE OF LABOURS:

- BHEL will not be liable for any medical attention, injury / loss of life of the persons engaged by the contractor in the Shot Blasting operations of Pipes at BHEL-PPPU, Thirumayam (T.N.) as per the contract. A suitable insurance coverage (ESI / Group Insurance) for the staff of contractor shall be arranged by the Contractor at contractor's cost from the first day of operation, towards medical treatment and compensation of any loss to their workmen as per legal provisions.
- 2. The contractor shall have full control over his employees including the right to appoint, determine service conditions, discharge, dismiss, or otherwise terminate their services at any time. The contractor shall be solely responsible for any claim arising out of employment or termination of employment of his employees and for statutory payments.
- 3. In case, during the contract period if ESI scheme comes into effect, the contractor shall conform to the statutory requirements and any additional cost involved shall be borne by the contractor only.
- 4. The contractor shall employ such personnel who are medically fit and above the age of 18 only. The company has the right to direct the contractor to remove from the premises such of his personnel who may be physically, hygienically, clinically or medically found to be unfit.
- 5. The contractor shall comply with the provisions of the Factories Act 1948, Contract Labour (regulation and abolition) Act 1970, ESI Act 1948, Workmen Compensation Act 1923, Employees Provident Fund and Miscellaneous Act 1952, Minimum Wages Act 1948, Payment of Wages Act 1936, Payment of Bonus Act 1965, Payment of Gratuity Act 1972, Tamil Nadu Catering Establishment Act, Tamil Nadu Industrial Establishment, (National & Festival Holidays) Act 1958 and the Rules framed there under or any other Laws and Rules as may be applicable from time to time in respect of the workers engaged by him. The contractor when required by the Company shall produce the registers and records for verification and comply with other directives issued by the company for compliance of the statutory provisions.
- 6. The Minimum Wages as prescribed and revised from time to time by the State Government should be paid to the contract Workers and the Wage and Attendance Registers should be produced to Welfare Section every month. The Minimum wages applicable for the Year 2014-2015 is provided below. Contractors are required to disburse wages as per the applicable wages as and when revised by the State govt. The details given shall be updated by the contractor with the concerned govt. authorities for the correctness.

- 7. Apart from the above, an additional monthly payment of Rs. 3200/- for Unskilled, Rs. 3700/- for Semi-Skilled worker and Rs 4100/- each for Skilled and Supervisor is to be made by the Contractor for their staff, as part of BHEL Policy. Hence the contractor has to ensure disbursement of State govt. prescribed minimum wages (as revised from time to time) plus the additional monthly wages as above.
- 8. Also the labourers shall be paid a minimum bonus which shall be 8.33% as per the payment of Bonus Act 1965 for the total wages paid (i.e.) Payment of minimum wages and additional payment as mentioned above.
- If the contractor employs more than twenty employees, he has to obtain Licence to this effect from the concerned statutory authority and renew the same periodically. FORM VI A and FORM VI B should be submitted for the contract as per the Contract Labour (R&A) Act.
- 10. The Contract workers should be fully aware of safety measures and observe all safety precautions during work. The contractor should also make his own arrangements to provide requisite safety devices to the workers, based on the nature of work. Any accident / incident occurring to his workers in Company's premises should be reported in writing by the Contractor to Safety, Welfare and Line Executive concerned.
- 11. A list containing the name of working person's photo, address, age, designation, nature of work is to be furnished immediately on receipt of the contract/work order. This is required for our records and issuance of Identity Card for Gate entry.

#### VI. <u>GENERAL TERMS & CONDITIONS:</u>

- **01. DEFINITION :-** In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires:-
- (a) The **"Contract"** means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.

- (c) The **"contractor"** means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
- (d) "The **Officer-In charge**" means, the Officer deputed by the, **Head of User Dept.** to supervise the work or part of the work.
- (e) "Approved" and "Directed" means, the approval or direction of Head of User Dept., or person deputed by him for the particular purposes.
- (f) BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company including Sr. Manager / CONTRACTS / PPPU authorized to invite tenders and enter into contract for works on behalf of the Company.
- (g) The **"Contract sum"** means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of the work during the currency of the contract.
- (h) A "week" means, Seven Days, without regard to the number of hours worked or not worked in any day in that week.
- (i) A **"day"** means, the day of 24 hours (TWENTY FOUR) irrespective of the number of hours worked or not worked in that day.
- (j) A **"working day"** means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a Holiday, and consists of the number of hours of labour as commonly recognized by good employers in the trade in the district where the work is carried out or as laid down in the BHEL regulations.
  - **02. HEADING TO THE CONTRACT CONDITIONS: -** The heading to these conditions shall not affect the interpretations thereof.
  - **03. WORK TO BE CARRIED OUT:-** The Contract shall, include all labour, materials, tools, plant, equipment and transport which may be required for the execution of the work. The Contractor will be deemed to have satisfied himself as to the nature of the site, local facilities of access and all matters affecting the execution of the work. No extra charges consequent on any misunderstanding in these respects or otherwise will be allowed.
  - **04. DEVIATIONS:-** The contractor shall not carry out any work not covered by schedule except in pursuance of the written instructions of BHEL. No such work shall be valid unless the same has been specifically confirmed and accepted by BHEL in writing and incorporated in the Contract.
  - **05. ASSIGNMENT OF TRANSFER OF CONTRACT:-** The Contractor shall not without the prior written approval of the BHEL, assign or transfer the contract or any part thereof, or any share, or interest thereon to any other persons. No sum of money which may become payable under the contract shall be payable to any person, other than the contractor unless the prior written approval of the BHEL to the assignment or transfer of such money is given.

**SUB-CONTRACT:-** The Contractor shall not sub-let any portion of the contract without the prior written approval of the BHEL.

**06. COMPLIANCE TO REGULATIONS AND BY- LAWS:** - The Contractor shall conform to the provisions of any statute relating to the work and regulations and Bye-Laws of any local authority. The Contractor shall be bound to give all notices required by statute regulations or By-Laws as aforesaid and to pay all fees and taxes payable to any authority in respect thereof.

- **07. REFUND OF SECURITY DEPOSIT ON TERMINATION:-** The Security Deposit mentioned above may be refunded to the Contractor after a period of 6 months in case of termination of the contract provided always that the Contractor shall first have been paid the last and final bill and have rendered a "NO DEMAND CERTIFICATE".
- **08. ORDERS UNDER THE CONTRACT:-** All orders, notices etc. to be given under the contract shall be in writing, type-script or printed and if sent by registered post to the address given in the tender of the Contract, shall be deemed to have been served on the date, when in the ordinary course they would have been delivered to him. The Contractor shall carry out without delay all orders given to him.

The Contractor shall not be allowed any compensation on this account.

- 10. LABOUR: The Contractor shall remain liable for the payment of all wages or other moneys to his work-people or employees under the payment of Wages Act 1936, Employees Liability Act. 1938, Workmen's Compensation Act 1923 or any other Act or enactment, relating thereto and rules framed, there under from time to time.
- 11. PRECAUTIONS AGAINST RISK: The Contractor shall be responsible for providing at his own expense for all precautions to prevent loss or damage from any and all risks and to minimize the amount of any such loss or damage and for the necessary steps to be taken for the said purpose.
- 12. DAMAGE & LOSS TO PRIVATE PROPERTY & INJURY TO WORKMEN :- The Contractor shall at his own expense reinstate and make good to the satisfaction of BHEL administration, and pay compensation for any injury, loss or damage occurred to any property or rights whatever including property and rights of BHEL (or agents) servants or employee of BHEL, the injury loss or damage arising out of or in any way in connection with the execution or purported execution of the contract and further the contractor shall indemnify, the BHEL against all claims enforceable against BHEL (or any agent, servant or employee of BHEL) or which would be so enforceable against BHEL where BHEL is a private person, in respect of any such injury (including injury resulting in death) loss or damage to any person whomsoever or property including all claims which may arise under the Workmen's Compensation Act or otherwise.
- **13. LAWS GOVERNING THE CONTRACT: -** The contract shall be governed by the Indian Laws for time being in force.
- 14. (i) Should a Bidder or a contractor has a dependent/relative or in the case of a partnership firm, any of its partners or dependents of partners employed in BHEL, the authority inviting tenders should be informed of this fact at the time of submission of the tender failing which tender may be disqualified or if such fact subsequently come to light, the contract may be cancelled.
  - (ii) No BHEL employee and their dependents are eligible to submit their offer against this tender.

**15. CANCELLATION OF CONTRACT FOR CORRUPT ACTS:** - BHEL, whose decision shall be final and conclusive, shall without prejudice to any other right or remedy which shall have accrued shall accrue thereafter to BHEL cancel the contract in any of the following cases and the Contractor shall be liable to make payment to BHEL for any loss or damage resulting from any such cancellation to the same extend as provided in the case of cancellation for default.

If the Contractor shall:-

- (c) Obtain a contract with BHEL as a result of cartel formation of tendering or by non-malafide methods of competitive tendering, without first disclosing the fact in writing to BHEL.

# 16. CANCELLATION OF CONTRACT FOR INSOLVENCY ASSIGNMENT OF TRANSFER OR SUB – LETTING OF CONTRACT

BHEL, without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases: If the Contractor,

(a) being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any

Bankruptcy Act for the time being in force for the sequestration of his estate or if a trust deed be granted by him on behalf of his creditors

OR

(b) being a Company, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a receiver or Manager on-behalf of the debenture holders shall be appointed or circumstances shall arise which entitle the Court or debenture holders to appoint a receiver or Manager,

OR

- (c) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.
- (d) Whenever BHEL exercise the authority to cancel the contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by AGM/Services which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by AGM/Services, or the same shall be recovered from the Contractor by other means.

(e) In case the BHEL carries-out the work under the provisions of this condition the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plants and/or labour provided by the BHEL with an addition of such percentage to cover superintendence and establishment charges as may be decided by the AGM/Services, whose decision shall be final and conclusive.

# 17. CANCELLATION OF CONTRACT IN PART OF FULL FOR CONTRACATOR'S DEFAULT: If the Contractor:

- (a) makes default in carrying out the work as directed and continues in that state after a reasonable notice from **Head of User Dept.** or his authorised representative ;
- (b) fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued there under ;
- (c) BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the contract as whole or in part thereof or only such work order or items of work in default from the contract. Whenever BHEL exercise the authority to cancel the contract as whole or part under this condition BHEL may complete the work at the contractor's risk and cost (as certified by **Head of User Dept.**, which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL. If the cost exceeds the moneys due to the Contractor under this contract the Contractor shall either pay the excess amount ordered by AGM/Services or the same shall be recovered from the Contractor by other means. In case the BHEL carries out the work or any part thereof under the provisions of the conditions the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plant and/or labour provided by the BHEL with an addition of such percentage to cover the superintendence and establishment charges as may be decided by the BHEL whose decision shall be final and conclusive.

#### 18. TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR. :-

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated BHEL shall have the option of terminating the contract without compensation to the Contractor.

- **19. SPECIAL POWER TO TERMINATION:-** If at any time after the award of contract, BHEL shall for any reason whatsoever not require whole or any part of the work to be carried out AGM/Services, shall give notice in writing of the fact to the Contractor who shall have no claim to any payment of compensation or otherwise howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the fore-closing of the work.
- 20. RECOVERY FROM CONTRACTOR:- Whenever under the contract, any sum of money, shall be recoverable from or payable by the Contractors, the same may be deducted from or any sum then due or which at any time thereafter may become due to Contractor under the contract or under any other contract with BHEL or from his Security Deposit or he shall pay the claim on demand.
- **21. POST TECHNICAL AUDIT OF WORK AND BILLS:-** BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner provided in the presiding sub-paragraphs. However no such recovery shall be enforced after three years of passing the final bill.

- 22. FORCE MEJEURE CLAUSE:- If, at any time during the continuance of this Contract the performance in whole or in part by either party of any obligations under this Contract shall be prevented or delayed by reason of any War, Hostile acts of the public enemy Civil Commotion, Epidemics, or Acts of God (Floods, Storm/Cyclone, Hurricane, Earth Quake etc.) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence therefore neither party shall by reason of such event be entitled to terminate this Contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the BHEL PPPU subject to prompt notification by the contractor.
- 23. ARBITRATION: All disputes between the parties to the contract, arising out-of or relating to the contract, other than those for which the decision of the Head of User Dept., or Accepting Officer or any other person is by the contract expressed to be final and conclusive shall after written notice by either party to the contract to the other party be referred to the sole Arbitration of Executive Director or other Officers of BHEL appointed as Arbitrator, by the Executive Director of BHEL in his sole discretion.

Unless the parties otherwise agree, such reference shall not take place until after the completion, alleged completion or abandonment of the work of the determination of the contract.

The venue of Arbitration shall be such a place or places as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final, conclusive and binding on both parties to the contract.

24. SIGNING OF CONTRACT: - Each contract document shall be signed by the Contractor with his usual signature. Contract by partnership of Hindu Joint Family firm, may be signed in the FIRM'S name by one of the Partners or the Karta or Manager as the case may be or by any other duly authorized representative followed by the name and designation of the persons so signing. - **26. REGISTERS & RECORDS:-** The Contractor shall maintain all registers and records in the proper manner and as required by the regulations of the various authorities concerned and indemnify the Employer from the consequences due to any inaccurate or faulty documentation on the part of the Contractor.
- 27. REMOTE TRANSACTIONS:- The Contractor shall agree to and comply with all such terms and conditions as BHEL may prescribe from time to time and shall confirm that all transactions effected by or through facilities for conducting remote transactions including the Internet, World Wide Web, electronic data interchange, call centers, tele-service operations (whether voice, video, data or combination thereof) or by means of electronic, computer, automated machines network or through other means of telecommunication established by BHEL shall constitute legally binding and valid transactions when done.

Under the above circumstances when dispute arises and the firm does not inform the change in the constitution of the firm BHEL reserves its rights for suspending or terminating the contract.

Rule 61-N and Rule 61- O: Workers to be provided with Personal Protective equipment suitable for the hazards and should be of good quality / have certification by Indian Standard Institute.
